of Chichester. "Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Alban, Preston, situate as aforesaid.

"Now, therefore, with the consent of the Right Reverend Charles John, Bishop of Chichester (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said Parish of Preston, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Alban, Preston, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Alban, Preston, Brighton.'

"And with the like consent of the said Charles John, Bishop of Chichester, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Alban, Preston, situate as aforesaid, and that the fees to be received in respect of the publication of such banns, and of the sclemnization or performance of the said offices, should be paid and belong to the Minister of the same Church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commis-sioners to concur in or approve the taking of any fee for the performance of the said office
