Hedge Accentor (Hedge Sparrow), Black-bird, Bullfinch, Bunting (all species), Chaffinch, Chiffchaff, Coot, Corncrake (Landrail), Crossbill, Cuckoo, Turtle Dove, Flycatcher (all species), Grebe (all species), Greenfinch, Lapping (Peewit or Green Plover), House Martin, Sand Martin, Moorhen, Nightingale, Nut-hatch, Pipit (all species), Water Rail, Robin, Shrike (all species), Swallow, Swift, Missel Thrush, Song Thrush, Tit (all species).
