interest arising from, or in connection with, such action which are subsisting or valuable at the said date unless the person who, by virtue of this Order, becomes entitled to restrain such reproduction or performance agrees to pay such compensation as, failing agreement, may be determined in accordance with the provisions of the Copyright Act, 1911.

(4) This Order shall come into operation on the 23rd day of December, 1914, which day is in this Order referred to as the commencement of this Order.

And the Lords Commissioners of the Treasury are to give the necessary orders accordingly.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 17th and 18th years of Her said late Majesty, Chapter 84, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 11th day of February, in the year 1915, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 17th and 18th years of Her said late Majesty, Chapter 84, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for apportioning the income of the Benefice (being a Vicarage) of St. Mary, Sandwich, in the County of Kent, and in the Diocese of Canterbury, between that Benefice and a certain other Benefice, namely, the Benefice (being a Vicarage) of Saint Clement, Sandwich, which said last-named Benefice is also situate in the said County of Kent, and in the said Diocese of Canterbury:

"Whereas the Right Reverend William,

Bishop of Dover, and Archdeacon of Canterbury, is the Patron, in right of his Archdeaconry, of the said Benefice of Saint Mary, Sandwich, and also of the said Benefice of Saint

Clement, Sandwich:

"And whereas it has been made to appear to us that the said Benefice of St. Clement, Sandwich, is at present insufficiently endowed; and that the said Benefice of Saint Mary, Sandwich, has endowments of such an amount that, after the charge hereinafter recommended and proposed to be made shall have been placed upon the same endowments, the said Benefice of Saint Mary, Sandwich, will still be sufficiently endowed:

"And whereas it has been represented to us, and we are of opinion, that it is desirable that additional provision should be made for the Cure of Souls within the Parish of Saint Clement, Sandwich, aforesaid, by means of that apportionment of the income of the said Benefice of Saint Mary, Sandwich, which is hereinafter recommended and proposed:

"And whereas the said Benefice of Saint Mary, Sandwich, is now full, the present Vicar or Incumbent thereof being the Reverend

Orlebar David Bruce Payne:

"And whereas the Governors of Queen Anne's Bounty hold in trust for the said Benefice of Saint Mary, Sandwich, a sum of £198 4s. sterling, being the proceeds of the sale of the Parsonage House lately belonging to the said Benefice, and also a sum of £143 13s. 8d. sterling, representing the dilapidation moneys in respect of the same House, and also the interest which has accrued in respect of the said two sums of money:

"Now, therefore, with the consent of the Right Honourable and Most Reverend Randall Thomas, Archbishop of Canterbury, acting as Bishop of the Diocese within which each of the said two Benefices is situate, (in testimony whereof he has signed this Scheme, and sealed the same with his Archiepiscopal Seal), and with the consent of the said William, Bishop of Dover, and Archdeacon of Canterbury, acting as the Patron, in right of his Archdeaconry, of each of the said two Benefices as aforesaid, (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said Orlebar David Bruce Payne, (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners. humbly recommend and propose that as from the day of the date upon which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette, and without any conveyance or assurance in the law other than such duly gazetted Order in Council ratifying the same, the two aforesaid sums of £198 4s. and £143 13s. 8d., now held by the Governors of Queen Anne's Bounty for the benefit of the Incumbent of the Benefice of
