#### PRIZE CLAIMS COMMITTEE.

This is to give notice, to all British, Allied or neutral persons having any such claims against the vessels mentioned below that such claims should be sent, with all necessary particulars, to the Secretary of the Committee, Board of Trade, Whitehall Gardens, London, S.W., as soon as possible, and in any case within three months of this date, after which they cannot be entertained.
