

consideration by a Committee of the Privy Council, on the 28th day of July, 1915, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the said Act:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, as it is hereby ordered, that no new burial ground shall be opened in the said Civil Parish save with the previous approval of the Local Government Board, and that burials in the said Parish shall be discontinued as follows, viz.:—

STOCKTON.—Forthwith and entirely in the Church of St. John the Baptist, in the Parish of Stockton, in the County of Wiltshire; and in the Churchyard attached thereto, with the following exceptions, that is to say:—

(a) In a vault or walled grave now existing in the said Churchyard, and belonging, or reputed to belong, to Mrs. John Fleming, burial may be allowed, subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented.

(b) In the family earthen graves now existing in the said Churchyard, the burial may be allowed of the bodies of Mr. Albert Edward Fleming and Mrs. Thomas Hayter Gay, at their decease, subject in each case to the condition that no part of the coffin containing the body shall be at a depth less than 3 feet below the level of the surface of the ground adjoining the grave.

(c) In the said Churchyard, in any grave space in which no interment has taken place within the period of 14 years prior to the date of this Order, the burial may be allowed of the bodies of the Right Reverend Huyshe Wolcott Yeatman-Biggs, D.D., Lord Bishop of Worcester, Mr. William Huyshe Yeatman-Biggs, Miss Margaret Barbara Yeatman-Biggs, or of any member of the above-named families, Miss Alice Walton, Mrs. Mary Anne Viney, Mrs. John Gay, the Reverend Arthur Goodman and his wife Mrs. Anna Maria Goodman, Mrs. E. J. Pope, Miss Arabella Giles, and Mr. John Cooper at their decease, subject in each case to the condition that no part of the coffin containing the body shall be at a depth less than 3 feet below the level of the surface of the ground adjoining the grave.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Sec-

tion one of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 28th day of July, 1915, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section one of the Exportation of Arms Act, 1900, and Section one of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited:

And whereas by an Order of Council, dated the 30th day of July, 1915, the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:—

That the Proclamation, dated the 28th day of July, 1915, as amended and added to by the Order of Council, dated the 30th day of July, 1915, should be further amended by making the following amendment in the same:—

That on and after the 13th day of August, 1915, the exportation of "Coal (including anthracite and steam, gas, household and all other kinds of coal) and coke," which is at present permitted to British Possessions and Protectorates and Allied Countries, should be prohibited to all destinations abroad other than British Possessions and Protectorates.

NOW, THEREFORE, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, the Director of the War Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
