Woodcote, Purley, all in the County of Surrey, and in the Diocese of Southwark, which, taken together, are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said Consolidated Chapelry of Saint Mark, Woodcote, Purley, from the said Parish of Coulsdon, at the junction of Smitham Downs Road and the Brighton .Road, and extending thence south-westward along the middle of the Brighton Road for a distance of 3 chains or thereabouts to its junction with Stoats Nest Road, and extending thence south-eastward along the middle of . Stoats Nest Road for a distance of 31 chains or thereabouts to a point opposite to the middle of the passage running along the north-western side of the house and premises known as Number 1, Mount Pleasant Villas, and extending thence north-eastward to and along the middle of the said passage for a distance of 11/2 chains or thereabouts to its junction with the passage running along the backs of the houses and premises situate on the north-eastern side of Stoats Nest Road, and known as Mount Pleasant Villas, and extending thence southeastward along the middle of such passage for a distance of 3 chains or thereabouts to its junction with the passage running along the south-eastern side of the house and premises known as Number 14, Mount Pleasant Villas, and continuing thence south-eastward, in precisely the same direction, and in a straight line, for a distance of 1½ chains or thereabouts to a point in the middle of the Old Main Line of the South Eastern Railway, and extending thence south-westward along the middle of the said Line of Railway for a distance of 13 miles or thereabouts to the point opposite to the boundary post at or near the fence on the western side of such Line of Railway where the boundary which divides the Parish of Chipstead, in the said County and Diocese, from the said Parish of Coulsdon, and also the boundary of the Urban District of Coulsdon and Purley, diverge north-westward from the said Line of Railway, and extending thence, first north-westward to the said boundary post, and then first north-westward and then in various directions along the said Urban District boundary (thereby following in one part the boundaries which divide the said Parish of Chipstead and the said Parish of Woodmansterne from the said Parish of Coulsdon, and in another part the boundary which divides the said Parish of Woodmansterne from the said Parish of Carshalton, and also crossing the boundary of the said Consolidated Chapelry of Saint Mark, Woodcote, Purley,) for a distance in all of 3 miles and 7 furlongs or thereabouts to the point where such Urban District boundary crosses the middle of Carshalton Lane, and extending thence south-eastward along the middle of Carshalton Lane for a distance of 9½ chains or thereabouts to its junction with Little Woodcote Lane and Smithambottom Lane, and extending thence south-eastward along the middle of Smithambottom Lane, the middle of Smithambottom Lane, and extending the middle of Smithambottom Lane, and the middle of Smithambottom Lan bottom Lane (thereby following for a short distance the boundary which divides the said Consolidated Chapelry of Saint Mark, Woodcote, Purley, from an isolated portion of the said Parish of Beddington), for a distance of 49 chains or thereabouts to its junction with Smitham Downs Road, and extending thence first south-eastward, and then southward, along the middle of Smitham Downs Road (thereby following in part the last-mentioned boundary

and in part the boundary which divides the said Consolidated Chapelry of Saint Mark, Woodcote, Purley, from the said Parish of Coulsdon) for a distance of 42 chains or thereabouts to its junction with the Brighton Road upon the last-mentioned boundary at which point the said imaginary line commenced."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwark.
