The Secretary of State for India in Council has appointed Frederick Golding Wallis to superintend the transfer of lascars or other persons at Tilbury and to grant the certificate required under Section 125 of the Merchant Shipping Act, 1894 (57 and 58 Vic., cap. 60).

The fee to be paid for every lascar, or other person in respect of whom such certificate is applied for, is limited to three shillings, and in no case is the total amount of fees in respect of one crew to exceed five pounds.

## NATIONAL INSURANCE ACT, 1911.

Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, acting jointly with the Insurance Commissioners, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by Section 15 of the National Insurance Act, 1911, and by the National Insurance (Joint Committee) Regulations, 1912 and 1913, to make further regulations with regard to the administration of Medical Benefit.
