

## LIGHT RAILWAYS ACTS, 1896 AND 1912.

South Yorkshire Joint Line (Firbeck Light Railway) Order.

The Light Railway Commissioners have submitted to the Board of Trade for confirmation, under the above-mentioned Acts, an Order made by them authorising the construction of a Light Railway in the West Riding of the county of York and in the county of Nottingham.
