perpetual right of Patronage of, and presentation to, the Church and Cure (hereinafter called 'the said Benefice') of Chalk, in the County of Kent, and in the Diocese of

"Whereas the Advowson or perpetual right of Patronage of, and presentation to, the said Benefice of Chalk is vested for an estate in fee simple, in possession, free from incumbrances, in Arthur Day, of Number 2, Millbank House, in the City of Westminster, and in the County

of Middlesex, Gentleman:
"And whereas the said Arthur Day is desirous that the whole Advowson or perpetual right of Patronage of, and presentation to, the said Benefice of Chalk now vested in him as aforesaid should be transferred to, and be vested in, the Right Reverend John Reginald, now Bishop of Rochester, and his Successors in the same Bishopric:

"And whereas the said John Reginald, Bishop of Rochester, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the Diocese which, by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, he, the said John Reginald, Bishop of Rochester, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Chalk which is hereinbefore mentioned, and hereinafter recommended and proposed, will in our opinion tend to make better provision for the Cure of Souls in the Parish or District in, or in respect of which, the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say in

the Parish of Chalk:
"Now, therefore, with the consent of the said Arthur Day (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said John Reginald, Bishop of Rochester, (in testimony whereof he has signed this Scheme, and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissions for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of, and presentation to, the said Benefice of Chalk, now vested in him the said Arthur Day as aforesaid, shall be transferred to the said John Reginald, Bishop of Rochester, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said John Reginald, Bishop of Rochester, and his Successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall

have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Rochester.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for authorizing the sale and disposal of certain property in the Parishes of Charlton Mackrell, Charlton Adam, and Babcary, in the County of Somerset, now vested in us:

"Whereas under and by virtue of an Indenture bearing date the 8th day of March, in the year 1866, and made between Samuel Jones, of the Parish of Abbots Leigh, in the County of Somerset, Engineer, and Henry Carpenter Ray, of the Parish of Iron Acton, in the County of Gloucester, Gentleman, of the one part, and us, the Ecclesiatical Commissioners for England, of the other part, all that the Manor or reputed Manor of Cary Fitzpain, in the County of Somerset, with all the commons, wastes, and rights thereto belonging, together with the messuages, lands, farms, tenements, and hereditaments described in the Schedule to the said deed, and shown by the green colour on the plan attached thereto, and also the tenths, or tithes, or rentcharges in lieu of tithes, described in the said deed, all situate in the Parishes of Charlton Mackrell, Charlton Adam, and Babcarry, in the said County of Somerset, became, with their appurtenances, and are now vested in us:

"And whereas under and by virtue of a certain other Indenture, bearing date the 22nd day of March, in the year 1878, and made between Walter Thomas Swayne, of Glastonbury, in the County of Somerset, Gentleman, of the first part, Eliza Jane Rocke, of Chalice Hill, Glastonbury, aforesaid, Widow, and the said Walter Thomas Swayne, of the second part, William Bartlett Cannon, of Babcary, in the said County of Somerset, Yeoman, of the third part, Edmund Burrough, of North Curry, in the said County of Somerset, Yeoman, of the fourth part, and us, the Ecclesiastical Commissioners for England, of the fifth part, certain land containing 16 acres 2 roods and 1 perch situate in the Parish of Babcary, in the said
