## The KING's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 16th and 17th years of Her late Majesty Queen Victoria, Chapter 50, and of the Act of the 23rd and 24th years of Her said late Majesty, Chapter 124, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 4th day of November, in the year .1915, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 16th and 17th years of Her late Majesty Queen Victoria, Chapter 50, and of the Act of the 23rd and 24th years of Her said late Majesty, Chapter 124, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting an exchange of the Patronage of the Benefice (being a Vicarage) of Kneesall, situate in the County of Nottingham and Diocese of Southwell, (which Benefice is hereinafter called the said Benefice of Kneesall) for the Patronage of the Benefice (being a Rectory) of Weston, otherwise Weston in the Clay, situate near Newark-upon-Trent, in the same County and Diocese, (which Benefice is hereinafter called the said Benefice of Weston):

of Weston): "Whereas the Advowson or perpetual right of Patronage and presentation of and to the said Benefice of Kneesall is vested in Your Majesty, Your Heirs, and Successors, and is exercised on behalf of Your Majesty by the Lord High Chancellor of Great Britain for the time being:

"And whereas under and by virtue of an Indenture of Settlement, bearing date the 21st day of June, 1876, and made between the Right Honourable Sydney William Herbert, Earl Manvers, (since deceased), and the Right Honourable Charles William Sydney, Earl Manvers, (then Viscount Newark, and hereinafter called Earl Manvers), of the first part, Thomas Bradshaw, and the Reverend Henry Seymour, of the second part, and the Reverend Evelyn Hardolph Harcourt Vernon, and Henry Sydney Seymour, of the third part, and of certain deeds and documents referred to in the Schedule to the Indenture of Appointment hereinafter referred to, and in the events which have happened, the Advowson or perpetual right of Patronage of and to the said Benefice of Weston now stands limited (with and
