(2). Statute XVII., as altered by the Governing Body on the 16th day of June, 1915.

(a) by substituting, in Clause 2, for the words "in agreement with the House" the words " after consultation with the House "; and

(b) by adding a twelfth Clause.

STATUTE XVII.—DR. LEE'S PROFESSORS AND READERS.

2. The election or appointment to the Lee's Professorships of Anatomy and Chemistry shall be made in each case by a Board of 7 persons, of whom one shall be the Dean and one other shall be nominated to hold office for a period of 5 years by the Governing Body. The election or appointment to the Lee's Professorship of Experimental Philosophy shall be made in accordance with the Statute made for the University concerning the Professor of Experimental Philosophy as amended by the University. Upon the occurrence of any vacancy in any of the Lee's Professorships, it shall be determined by the University, after consultation with the House, what part or parts of the science concerned shall be assigned to the Professorship so falling vacant during the tenure of office of the person next elected thereto.

12. The provisions of the Statute made by the University of Oxford Commissioners on the 16th day of June, 1881, in part for the University and in part for the Cathedral or House of Christ Church, concerning Dr. Lee's Readers, and approved by Her late Majesty Queen Victoria in Council on the 3rd day of May, 1882, in so far as it is a Statute for Christ Church, are hereby repealed.
