The Local Government Act, 1894.

NEWTON FAIR.

Whereas a representation has been duly made to me, as Secretary of State for the Home Department, by the Urban District Council of Newton-in-Makerfield to the effect that it would be for the convenience and advantage of the public that the Fair which has been held annually on the 17th day of May and the 11th and 12th days of August at Newton, in the county of Lancaster, should be abolished:

And whereas notice of the said representation and of the time when I would take the same into consideration has been duly published in pursuance of the Fairs Act, 1871:

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished :

Now, therefore, I, as Secretary of State for the Home Department, in exercise of the powers vested in me by the Fairs Act, 1871, do hereby order that the Fair which has been held annually on the 17th day of May and the 11th and 12th days of August at Newton, in the county of Lancaster, shall be abolished.
