SCHEDULE.

ZONE I.

A Zone, in the administrative county of Somerset, comprising:—

The borough of Wells, and such portion of the borough of Glastonbury as lies to the north and east of the road from West Pennard to Meare (via Edgarley, Chilkwell St., Wells Road, Manor House Road, Manor Farm, and Northload Bridge Farm);

The parishes of Priddy, Westbury, Wookey, St. Cuthbert Out, North Wootton, West Pennard, Pilton, Pylle, Shepton Mallet, Croscombe, Dinder, and Ashwick; and

Such portions of the parishes of Binegar, Emborough, and Chewton Mendip as lie to the south and west of the road leading from Chilcompton to East Harptree (viâ Old Down Inn, Emborough, Swallow Pits Farm, Coles Lane, Chewton Mendip, and Waldegrave House).

(Any road or part of a road forming the boundary of the above Zone is excluded from the Zone.)

ZONE II.

A Zone, in the administrative county of Somerset, comprising:—

The petty sessional division of Kilmersdon (excluding the parishes of Foxcote, Hemington, and Hardington);

Such portions of the petty sessional divisions of Shepton Mallet, and Wells (including the borough of Glastonbury), as are not comprised within Zone I.;

The parishes of Blagdon, Burrington, Charterhouse, Cheddar, Nyland cum Batcombe, Wedmore, Shapwick (excluding its detached part), Ashcott, Compton Dundon, Kingweston, Barton St. David, Keinton Mandeville, West Lydford, East Lydford, Wheathill, Lovington, Alford, Castle Cary, Ansford, Wanstrow, Whatley, Mells, Leigh upon Mendip, Ston Easton, Farrington Gurney, Paulton, High Littleton, Clutton, Camely, North Widcombe, Hinton Blewett, Litton, East Harptree, West Harptree, Compton Martin, and Ubley;

Such portions of the parishes of Stowey, Chew Magna, Chew Stoke, Winford, and Nempnett Thrubwell as lie to the south of the road leading from Chelwood (vià Golds Cross, Double Farm, Hollow Brook, Woodford House, Chew Stoke, Grabble Hill, Nempnett, and Nempnett Farm) to Butcombe, but excluding that road;

Such portions of the parishes of Nunney and Cloford as lie to the north and west of the road leading from Bruton (via Wanstrow and Marston House) to Frome, but excluding that road; and

Such portions of the parishes of North Brewham and Bruton as lie to the north and west of the Great Western Railway line from Frome to Castle Cary.
