the Parish (sometime District under the firstly herein-before mentioned Act) of Saint Werburgh, Chorlton cum Hardy, and partly out of the Parish (sometime District under the Parish of Manchester Division Act, 1850) of Saint Edmund, Whalley Range, all within the original limits of the Parish of Manchester, in the County of Lancaster, and in the Diocese of Manchester:

"Whereas we are satisfied that the said Parish of the Holy Innocents, Fallowfield, the said Parish of Saint Werburgh, Chorlton cum Hardy, and the said Parish of Saint Edmund, Whalley Range, are Parishes wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said Parish of the Holy Innocents, Fallowfield, of the said Parish of Saint Werburgh, Chorlton cum Hardy, and of the said Parish of Saint Edmund, Whalley Range, which are hereinafter mentioned and described, should be constituted a Separate District in the manner which is herein-after set forth:

"And whereas there is not at present within the limits of the said proposed District any Consecrated Church or Chapel in use for the purposes of Divine Worship:

}

"And whereas we are satisfied that an adequate and permanent maintenance for the support of the Minister of the said proposed District, and, when the said District shall have become a New Parish, then for the support of the Incumbent thereof will be secured as from the date of the licensing or appointment of such Minister or Incumbent by the payment of a sum of not less than £150 0 0, which will be annually provided out of the moneys received by us, the said Ecclesiastical Commissioners, under the provisions of the said Parish of Manchester Division Act, 1850:

"And whereas the Right Honourable Alan de Tatton, Baron Egerton de Tatton, has by a Deed of Conveyance dated the 11th day of November, in the year 1915, conveyed to us a plot of land situate within the said proposed Separate District as the site for a permanent Church for such District:

"And whereas the Bishop of Manchester's Commission for Manchester and Salford, having received a promise of a sum of £1,000 0 0 sterling from the said Alan de Tatton, Baron Egerton de Tatton, have agreed to contribute that sum towards the cost of the erection of the said proposed permanent Church:

"And whereas the Manchester Diocesan Church Building Society has undertaken to contribute a sum of at least $\pounds 250\ 0\ 0$ sterling towards the cost of the erection of the said proposed permanent Church:

"And whereas the said plot of land has been conveyed, and the said sums of £1,000 0 0 and £250 0 0 will be contributed as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) we should recommend and propose to Your Majesty in Council that the whole right of Patronage of the said proposed District or New Parish, and the nomination of the Minister or Incumbent thereof, should be assigned in the manner which is herein-after set forth:

"And whereas the said Alan de Tatton, Baron Egerton de Tatton, the said Bishop of Manchester's Commission for Manchester and Salford, and the said Manchester Diocesan Church Building Society, have nominated the Right Reverend Edmund Arbuthnott, Bishop of the said Diocese of Manchester, as the person to whom, and to whose Successors, they desire that the whole right of Patronage of the said proposed District or New Parish should be assigned:

"Now, therefore, with the consent of the said Edmund Arbuthnott, Bishop of Manchester, (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said Parish of the Holy Innocents, Fallowfield, of the said Parish of Saint Werburgh, Chorlton cum Hardy, and of the said Parish of Saint Edmund, Whalley Range, which are more particularly described in the Schedule hereunder written, and are delineated and set forth on the Map or Plan hereunto annexed, shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme become and be constituted a Separate District for spiritual purposes, and that the same shall be named 'The District of Saint Crispin, Withington.'

"And we further recommend and propose that the whole right of Patronage of the said District so recommended to be constituted, and, when such District shall have become a New Parish as aforesaid, then of the said New Parish, and the nomination of the Minister or Incumbent thereof, shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid, be assigned to and be absolutely vested in and shall and may be exercised by the said Edmund Arbuthnott, Bishop of Manchester, and by his Successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Crispin, Withington, comprising :----

"All those contiguous portions of the Parish (sometime District under the Parish of Manchester Division Act, 1850) of the Holy Innocents, Fallowfield, of the Parish (sometime District) of Saint Werburgh, Chorlton cum Hardy, and of the Parish (sometime District under the Parish of Manchester Division Act, 1850) of Saint Edmund, Whalley Range, all within the original limits of the Parish of Manchester, in the County of Lancaster, and in the Diocese of Manchester, which, taken together, are bounded upon the north partly by the Parish of Saint James, Moss Side, and partly by the Parish of Christ Church, Moss Side, upon the east by the Parish of the Holy Trinity at Rusholme, all in the said County
