LONDON COUNTY COUNCIL.

SPECIAL ACTS (EXTENSION OF TIME) ACT,
1915.

WHEREAS by the Education Board Provisional Orders Confirmation (London, No. 1) Act, 1912, the London County Council were authorised to put in force the powers of the Lands Clauses Acts for the compulsory purchase and taking of the lands set forth in the Schedule hereto:
