

whereof she has signed and sealed this Scheme), and with the consent of the said Edward Stuart, Bishop of Winchester, (in testimony whereof he has signed this Scheme, and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Mary, Oatlands, now vested in her the said Frances Louisa Askew as aforesaid, shall be transferred to the said Edward Stuart, Bishop of Winchester, and his Successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said Edward Stuart, Bishop of Winchester, and his Successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Winchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty, Chapter 63, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 9th day of March, in the year 1916, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 6th and 7th years of His late Majesty King William the Fourth, Chapter 77, of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 37th and 38th years of Her said late Majesty, Chapter 63, have prepared, and now humbly lay before Your Majesty in Council, the fol-

lowing Scheme for making certain new arrangements with respect to the Archdeaconry of Dorset, in the Diocese of Salisbury, and for constituting a new Archdeaconry within the said Diocese of Salisbury, and for endowing such new Archdeaconry:

"Whereas the said Diocese of Salisbury now comprises three Archdeaconries, and no more, namely, the Archdeaconry of Dorset, the Archdeaconry of Sarum, and the Archdeaconry of Wilts:

"And whereas the Right Reverend Frederic Edward, Bishop of Salisbury, has represented to us, and it appears to us to be expedient, that the arrangements which are herein-after recommended and proposed with respect to the said Archdeaconry of Dorset, and with respect to some of the Rural Deaneries within such Archdeaconry, should be made, and that a new Archdeaconry should be constituted within the said Diocese of Salisbury, and should comprise the Rural Deaneries which are herein-after recommended and proposed to be comprised therein, and which are at present within the said Archdeaconry of Dorset, and that such new Archdeaconry should be endowed in the manner which is herein-after recommended and proposed:

"And whereas it appears to us to be undesirable that procurations, synodals, visitation fees, and induction fees, should be received by the Archdeacon of the said proposed new Archdeaconry:

"And whereas it has been made to appear to us that by reason of the discontinuance of the collection of the said fees there will be no annual income available for the said proposed Archdeaconry from fees, dues, and emoluments, and that the grant herein-after recommended and proposed will not be such as to raise the annual income of the said proposed Archdeaconry to an amount exceeding £200 0s. 0d.:
