duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 9th day of March, in the year 1916, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a Separate District for spiritual purposes to be taken out of the Parish of Kettering, in the County of Northampton, and in the Diocese of Peterborough:

"Whereas we are satisfied that the said Parish of Kettering is a Parish wherein, or in parts whereof, the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, and it has been made to appear to us that it would promote the interests of religion that the particular part of the said Parish of Kettering, which is hereinafter mentioned and described, should be constituted a Separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed Separate District any Consecrated Church or Chapel in use for the purposes of Divine Worship: "And whereas by a certain Indenture bear

And whereas by a certain Indenture, bearing date on or about the 9th day of March, in the year 1916, and made or expressed to be made under the authority of the 'New Parishes Acts, 1843, 1844, and 1856,' or some or one of them, between the Reverend Charles Burrard Lucas, Rector of the Rectory of the said Parish of Kettering, of the first part, the Reverend Wentworth Watson, of Rockingham Castle, Uppingham, in the County of Rutland, Patron of the said Rectory of the Parish of Kettering, of the second part, the Honourable and Right Reverend Edward Carr, Bishop of Peterborough, the Ordinary of the said Rectory, of the third part, and us, the said Ecclesiastical Commissioners, of the fourth part, (which Indenture is intended to be enrolled in the Chancery Division of the High Court of Justice), the said Charles Burrard Lucas did, with the consent of the said Wentworth Watson, as such Patron as aforesaid, and of the said Edward Carr, Bishop of Peterborough, as such Bishop as aforesaid, Firstly, grant and convey unto the Minister of the District hereinafter recommended to be constituted, so soon as a Minister shall have been licensed, and to his Successors, and when such District shall have become a New Parish then to the Vicar or Incumbent of such New Parish, and to his Successors for the time being, certain pieces or parcels of land situate in the said Parish of Kettering containing 25 acres, 1 rood, and 31 perches or thereabouts, and hitherto forming part of the glebe land belonging to the said Rectory of the Parish of Kettering, as and for an endowment for the said proposed District, and, Secondly, assign unto us, the said Eccle-Commissioners, siastical the sums of £869 0s. 0d. South Eastern Railway Company 5 per cent. Consolidated Preference Stock, £2,686 0s. 0d. London and North Western Railway Company Consolidated 4 per cent. Preference Stock, £200 0s. 0d. London and North Western Railway Company Consolidated 4 per cent. Preference Stock, and £2,022 0s. 0d. Western Australia Government 4 per cent. Inscribed Stock (1942-1962) now

standing in the names of us, the said Ecclesiastical Commissioners, as part of the endowments of the said Rectory of the Parish of Kettering, to have and to hold for or towards the further endowment of the Minister or Incumbent of the said intended District, so soon as one shall have been licensed, and of his Successors Ministers or Incumbents thereof for the time being, Provided always that the two last-mentioned sums of Stock shall also be applicable for the further purpose of providing a House of Residence for the said Minister or Incumbent:

"And whereas the said pieces or parcels of land have been so granted and conveyed as aforesaid, and the said sums of Stock have been assigned as aforesaid, upon the understanding and condition that (such arrangement appearing to us to be expedient) we should recommend and propose to Your Majesty in Council that the whole right of Patronage of the said intended District or New Parish, and the nomination of the Minister or Incumbent thereof, should be assigned in the manner which is hereinafter set forth:

"And whereas the said Charles Burrard Lucas has nominated himself as the person to whom he desires that the first turn of the Patronage of the said proposed District shall be assigned, and the Venerable Edward Marsham Moore, of The Rectory, Uppingham, Clerk in Holy Orders and Archdeacon of Oakham, the said Wentworth Watson, the Reverend Reginald Henry Duthy, of The Rectory, Thorpe Malsor, Kettering, Clerk in Holy Orders, Edwin Forbes Jeffries, of Market Harborough, Solicitor, and Alexander Hamilton Thompson, of Gretton, Kettering, Esquire, as the persons to whom he, the said Charles Burrard Lucas, desires that the whole right of Patronage of the said proposed District or New Parish, after the exercise of the said first turn,

shall be assigned: "Now, therefore, with the consent of the said Edward Carr, Bishop of Peterborough, (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all that part of the said Parish of Kettering which is described in the Schedule hereunder written, all which part together with the boundaries thereof is delineated and set forth on the Map or Plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid, become and be constituted a Separate District for spiritual purposes, and that the same shall be named 'The District of All Saints, Kettering.'

"And we further recommend and propose that the whole right of Patronage of the said District so recommended to be constituted, and when such District shall have become a New Parish as aforesaid then of the said New Parish, and the nomination of the Minister or Incumbent thereof, shall, without any assurance in the law other than this Scheme, and any duly gazetted Order of Your Majesty in Council ratifying the same, and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid, be assigned to and be absolutely vested in, and shall and may be exercised by, the said Charles Burrard Lucas, his heirs and assigns, for the first turn of presentation, and that the whole remainder of such right of Patronage, that is
