#### NATIONAL INSURANCE ACTS, 1911 to 1915.

Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by Section 2 of the National Insurance (Part I. Amendment) Act, 1915, and by the National Insurance (Joint Committee) Regulations, 1915, to make regulations, with the consent of the Treasury, providing that Section 2 of the National Insurance (Part I. Amendment) Act, 1915, shall apply to any Government scheme for compensation in respect of persons injured in any merchant ship or fishing vessel as the result of hostilities during the present war.

#### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 31ST MARCH 1916.)

#### MAINTENANCE OF LIVE STOCK ORDER OF 1916.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Maintenance of Live Stock Act, 1915, and for the purpose of maintaining a sufficient stock of cattle, do hereby order as follows:—

*Amendment of the Maintenance of Live Stock Order of 1915.*

1. The Maintenance of Live Stock Order of 1915 is hereby modified in the following manner:—

(1) Paragraph (2) of Article 2, which exempts from the restriction of slaughter calves of cows of certain dairy breeds, is hereby revoked;

(2) In paragraph (3) of Article 2 the sum of forty shillings shall be substituted for the sum of thirty shillings;

(3) Article 3 (*Exceptions from Restrictions*) shall be read as if it contained the following paragraph:—“(d) slaughter of a calf in any area in which, by an Order under the Diseases of Animals Acts 1894 to 1914, relating to foot-and-mouth disease, the sale of calves at a market or sale-yard is prohibited or restricted to animals intended for immediate slaughter.”

#### *Commencement.*

2. This Order shall come into operation on the tenth day of April, nineteen hundred and sixteen.

#### *Short Title.*

3. This Order may be cited as the MAINTENANCE OF LIVE STOCK ORDER OF 1916.
