

his estate of certain scholarships to be tenable at colleges in the University of Oxford by students of German birth to be nominated by the German Emperor for the time being, and to abolish the scholarships established by the Trustees (which expression where used in this Notice includes all persons for the time being Trustees of the said Will), pursuant to the directions contained in the said codicil.

To make all such provisions (if any) as may be deemed necessary or expedient for extinguishing all or any rights with respect to the said scholarships which may immediately before the date of the outbreak of the present war have been vested in the students of German birth holding at that date the said scholarships or nominations thereto.

To provide for the establishment out of the funds in the hands of the Trustees formerly applicable to the payment of the said scholarships or the income of such funds or out of part of such funds or income of scholarships to such number, and to be tenable at any college in the said University by students from such countries or places in the British Empire or British Colonies or Dependencies as may be determined by the Trustees in substitution for the scholarships to be abolished by the intended Act, and to authorize and provide for the application for that purpose of the said funds and income or part thereof.

To make provisions as to the qualifications to be possessed by and the mode of election or nomination of candidates for the said substituted scholarships, and as to the tenure of and otherwise with respect to such scholarships and the persons for the time being holding the same, and (if thought fit) to provide for and authorize the making, variation, repeal and enforcement of regulations by the Trustees with respect to all or any of the said matters or any matter connected therewith or incidental thereto.

To empower the Trustees to authorize the making, variation and repeal of regulations with respect to the said matters or such of them as may be specified in the Bill by Ministers of Education in any country, colony, dependency or place from which students are qualified for election to the said substituted scholarships, or by such other persons (if any) as may be specified in the Bill, and to provide that subject to the approval of the Trustees regulations so made shall have the same force and effect as regulations made by the Trustees.

The intended Act will or may apply to the said substituted scholarships and the candidates therefor and the persons for the time being holding the same all or some of the provisions contained in the said Will with respect to certain other scholarships thereby directed to be established, and to the candidates therefor and the persons for the time being holding the same or will make new provisions with respect to all or any of those matters.

To make provision (in the event of the funds in the hands of the Trustees or the income of such funds available for the payment of the said scholarships established pursuant to the directions contained in the said Will and of the substituted scholarships to be established pursuant to the intended Act and of certain other scholarships established by the Trustees in exercise of the general discretion vested in them under the said Will proving insufficient for the payment of all the said scholarships) as to the abatement and the order of priority of payment

of the said several scholarships, and if thought fit to provide for the ranking of the said substituted scholarships for payment in the same order or manner as the scholarships to be abolished by the intended Act.

To authorize the Trustees either in the event of insufficiency of funds or income for the payment of all the said substituted scholarships or in any such other event as may be specified in the Bill from time to time either temporarily or permanently to reduce the number of or to discontinue the payment of such substituted scholarships and to make such provisions (if any) as may be deemed necessary or expedient with respect to the rights existing at the date on which any such reduction or discontinuance shall take effect of persons holding such scholarships or any of them or entitled to any beneficial or other interest therein or of persons having any right of nominating or electing students to such scholarships, and to vary or extinguish either temporarily or permanently all or any of such rights.

To make all such other provisions as may be deemed necessary or expedient for or with respect to all or any of the matters aforesaid or any matter connected with or incidental to the same or with or to the objects and purposes of the intended Act.

To vary or extinguish all existing rights and privileges which would or might in any way prevent or interfere with the accomplishment of the objects of the intended Act or any of those objects and to confer other rights and privileges.

Printed copies of the proposed Bill will be deposited in the Private Bill Office of the House of Commons if and so soon as leave shall be given to introduce the Bill.

INCOME TAX.
