

side, that is to say, upon the north-west, by an imaginary line commencing upon the boundary which divides the said Parish of Bentham from the said Parish of Tatham, and the said County of York from the said County of Lancaster, at the centre of Eskew Bridge which carries the road connecting Eskew Lane with Long Lane across the stream known as Eskew Beck, and extending thence south-westward along the middle of Long Lane for a distance of 60 chains or thereabouts to its junction with the road leading to Lowgill, and extending thence first south-eastward, and then southward, along the middle of the last-mentioned road for a distance of 21 chains or thereabouts to its junction with Furnaceford Road, and extending thence first south-westward, and then in various directions, along the middle of Furnaceford Road for a distance of 40 chains or thereabouts to the centre of Furnaceford Bridge which carries the road connecting Furnaceford Road with Park House Lane across the River Hindburn, and extending thence westward along the middle of Park House Lane for a distance of 2½ chains or thereabouts to the point where it is crossed by the boundary which divides the said Parish of Tatham from the said New Parish of the Trinity, Wray."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Manchester.

The Governor and Company of the Bank of England are authorized by the Lords Commissioners of His Majesty's Treasury to receive on the 2nd June, 1916, and thereafter until further notice, applications for Exchequer Bonds as above.

The Principal and Interest of the Bonds are chargeable on the Consolidated Fund of the United Kingdom.

The Bonds will be issued in denominations of £100, £200, £500, £1,000 and £5,000, and will bear interest at £5 per cent. per annum, payable half-yearly by coupon, the first coupon on each Bond representing interest from the date upon which payment for the Bond is made until the next succeeding day on which a half-yearly payment of interest is due.

In the event of future loans (other than issues made abroad or issues of Exchequer Bonds, Treasury Bills, or similar short-dated securities) being raised by His Majesty's Government for the purpose of carrying on the War, Bonds of this issue will be accepted, together with all undue Coupons, as the equivalent of cash to the amount of their face value for the purpose of subscription to any such loan. Interest accrued to the date of the surrender of a Bond will be paid in cash.

Bonds of this issue, and the Interest payable from time to time in respect thereof, will be exempt from all British taxation, present or future, if it is shown in the manner directed by the Treasury that they are in the beneficial ownership of a person who is neither domiciled, nor ordinarily resident, in the United Kingdom of Great Britain and Ireland. Where a Bond belongs to such a holder, the relative Coupons will be paid without deduction for Income Tax, or other taxes, if accompanied by a declaration of ownership in such form as may be required by the Treasury.

Every application must specify whether the Bonds applied for are to be repayable on the 5th October, 1919, or on the 5th October, 1921. Two Forms of Application must be used where Bonds of each maturity are required.

Applications for Bonds, which must in every case be accompanied by payment of the full amount payable in respect of the Bonds applied for, may be lodged by hand at the Bank of England, Threadneedle Street, E.C., on any business day between the hours of 10 a.m. and 2 p.m. (Saturdays between 10 a.m. and 12 noon); or they may be forwarded to the Bank through the post. Where payment is made otherwise than in cash or Banker's draft on the Bank of England, the amount of the first interest payment in respect of the relative Bonds will be calculated as from the date on which the proceeds of the payment are actually received by the Bank.
