(Dated 2nd June, 1916.)

Whereas by the 21st Section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-districts:

1. And whereas it is expedient that Walpole St. Peter Sub-district of Wisbech Registration District should be united with Terrington St. Clement Sub-district of the same Registration District, and that the enlarged Sub-district should be called and known as Terrington St.
