

to be affixed to this Representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said Parish of Saint Mary, Southampton, of the said Parish of Hound, of the said New Parish of Saint Mary, Scholing, of the said New Parish of the Holy Saviour, Bitterne, and of the said District of the Ascension, Bitterne Park, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the Map or Plan hereunto annexed, should be united and formed into one Consolidated Chapelry for the said Church called Jesus Chapel, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Mary Extra, Southampton.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal Consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal Wisdom shall seem meet.

"THE SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Mary Extra, Southampton, comprising:—

"All those contiguous portions of the Parish of Saint Mary, Southampton, of the Parish of Hound, of the New Parish (sometime Consolidated Chapelry) of Saint Mary, Scholing, of the New Parish (sometime District) of the Holy Saviour, Bitterne, and of the District of the Ascension, Bitterne Park, all in the County of Southampton, and in the Diocese of Winchester, which are comprised within and are bounded by an imaginary line commencing at the point in the middle of the River Itchen at Itchen Ferry where the boundaries of the said Parish of Saint Mary, Southampton, the New Parish of Saint James, Bernard Street, and the New Parish of Saint Mark, Woolston, both in the said County and Diocese, all meet, and extending thence eastward along the boundary which divides the said New Parish of Saint Mark, Woolston, from the said Parish of Saint Mary, Southampton, (thereby following in part the middle of Portsmouth Road), for a distance of 32½ chains or thereabouts to the junction of Portsmouth Road with Vicarage Road, where the last-mentioned boundary meets the boundary which divides the said New Parish of Saint Mark, Woolston, from an isolated portion of the said Parish of Hound, and extending thence eastward along the last-mentioned boundary (thereby continuing to follow the middle of Portsmouth Road) for a distance of 2½ chains or thereabouts to the point where such boundary meets the boundary which divides the said New Parish of Saint Mary, Scholing, from the said isolated portion of the Parish of Hound at the junction of Portsmouth Road with Manor Road, and extending thence northward along the last-mentioned boundary (thereby following the middle of Manor Road) for a distance of 11 chains or thereabouts to the junction of Manor Road with Avenue Road, and extending thence eastward along the middle of Avenue Road for a distance of 10 chains or thereabouts to its junction with High Street, and extending thence north-eastward along the

middle of High Street for a distance of 36 chains or thereabouts to its junction with Sholing Lane, and extending thence westward along the middle of Sholing Lane for a distance of 9½ chains or thereabouts to its junction with Merryoak Road, and extending thence north-eastward along the middle of Merryoak Road for a distance of 35 chains or thereabouts to its junction with Spring Road, and extending thence north-westward along the middle of Spring Road (thereby crossing the boundary which divides the said New Parish of Saint Mary, Scholing, from the said New Parish of the Holy Saviour, Bitterne, and also the boundary which divides the last-mentioned New Parish from the said Parish of Saint Mary, Southampton) for a distance of 19 chains or thereabouts to its junction with the road running along the south-eastern side of Freemantle Common, and extending thence in a straight line due west (thereby crossing Freemantle Common, Redmoor Copse, and the Netley and Fareham Line of the London and South Western Railway, and also crossing the boundary which divides the said Parish of Saint Mary, Southampton, from the said District of the Ascension, Bitterne Park) for a distance of 41½ chains or thereabouts to a point in the middle of the River Itchen upon the boundary which divides the said District of the Ascension, Bitterne Park, from the New Parish of Christ Church, Northam, in the said County and Diocese, and extending thence first southward, then south-westward, and then south-eastward, along the middle of the River Itchen (thereby following in one part the last-mentioned boundary, and in another part the boundary which divides the said New Parish of Christ Church, Northam, from the said Parish of Saint Mary, Southampton) for a distance of 1¼ miles or thereabouts to the point at Itchen Ferry where the boundaries of the said Parish of Saint Mary, Southampton, the said New Parish of Saint James, Bernard Street, and the said New Parish of Saint Mark, Woolston, all meet, at which point the said imaginary line commenced."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Winchester.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the
