SPECIAL REGULATIONS respecting an Open Com-PETITIVE EXAMINATION for the situation of ESTABLISHED CLERK TO SURVEYOR OF TAXES under the Board of Inland Revenue (Supplementary to the General Regulations respecting Open Competitive Examinations for Situations in the Civil Service, included in Schedule A of the Order in Council of 10th January, 1910).

N.B.—These Regulations are liable to alterations as necessity may arise.

1. The limits of age for this situation are 16 and 17, and Candidates must be of the prescribed age on the 1st of November, 1916.

2. Naturalised British Subjects are not eligible to compete except with special permission of the Civil Service Commissioners.

3. The Examination will be in the following subjects:
