WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 17th and 18th years of Her said late Majesty, Chapter 84, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 18th day of May, in the year 1916, in the words and figures following, that is to say :—
