### COAL MINES ACT, 1911.

The Secretary of State for the Home Department gives notice that on 7th July, 1916, he made the following Order in pursuance of Section 33 of the Coal Mines Act, 1911:---

"The date by which approved flame safety lamps in use before 1st March, 1913, must comply with the requirements specified in the Schedule hereto is postponed from 1st January, 1916, to 1st July, 1917, except in any case in which H.M. Divisional Inspector of Mines shall direct that the requirements must be complied with forthwith."

#### SCHEDULE.

1. Every flame safety lamp shall be provided with double gauzes or with some other adequate arrangement serving the same purpose.

2. If lamp pillars are used, the pillars shall be so arranged that a straight line touching the exterior parts of consecutive pillars does not touch the glass.

3. Lamps shall not be fitted with screw locks.

## BIRMINGHAM INDUSTRIAL SCHOOL FOR BOYS, SHUSTOKE.

The Secretary of State for the Home Department hereby gives notice that, being satisfied that there is accommodation at the Birmingham Industrial School for Boys at Shustoke for one hundred and eighty-six inmates, he has sanctioned an increase of twenty in the number of inmates of the said School for one year from the present date.

The number of inmates at any one time in the said School, whether sent thereto in pursuance of the provisions of the Children Act, 1908, or of the Elementary Education Act, 1876, or otherwise, shall not exceed one hundred and eighty, excluding boys recalled to the School by the revocation of their licences under Sections 67 and 68 of the Children Act, and the total number of inmates, including boys so recalled, shall not at any one time exceed one hundred and eighty-six.
