DEFENCE OF THE REALM (LIQUOR CONTROL).

GENERAL ORDER (AMENDING) OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) RELATING TO THE SALE OF MEDICATED WINES.

We the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm hereby make the following general Order:—

The following provision shall be inserted in any Order of the Board which has been made with reference to the sale of Medicated Wines:—

“Provided also that in any case where such medicated wine or mixture or preparation is sold or supplied in a bottle or other vessel enclosed in a sealed packet and is so sold or supplied at any time before the 9th day of October, 1916, it shall be deemed to be a sufficient compliance with the terms and conditions of this Order if such sealed packet bears such label.”
