Notice is hereby given, that the County Council of Anglesey have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising the following parts of roads, that is to say—

In the Borough of Beaumaris:—

The road (including Castle Street) extending from the southern end of Trosyrafon Bridge to a point opposite the Castle meadow Gate.

Church Street, from the Arch in Castle Street to its junction with Wexham Street. In the Urban District of Amlwch:—

So much of the Tan-y-Bryn Road as extends from the Pentrefel-in Cross Roads to its junction at the Gardeners' Arms Inn with the road leading to Holyhead.

The road (including Bethesda Street, Mona Street, Market Street, Wesley Street, Machine Street, Chapel Street and Llan-eilian Road) extending from the Gardeners' Arms Inn to the eastern extremity of Llan-eilian Road.

The road (including Salem Street, Queen Street and Dinorben Square) extending from the southern extremity of Salem Street to Graig Wen on the Bull Bay Road.

In the Rural District of Twrcelyn:—

So much of the road through the village of Benllech as extends from Avondale, past the Glanrafon Hotel to Hyfrydle on the coastal main road.

Notice is hereby further given, that objections to the making of any such regulation may be sent in writing to the Local Government Board at their offices at Whitehall, London, on or before the Twenty-ninth day of August, 1916.

A copy of any such objection should be sent at the same time by the objector to the County Council of Anglesey, County Offices, Llangefni.

**INSTRUMENT** substituting the new Church of Saint Cadmarch, situate within the parish of Llangammarch, in the county of Brecknock and in the diocese of Saint David's, for the old Church of Saint Cadmarch, formerly situate within and hitherto being the parish church of the same parish, but now pulled down.

To all to whom these presents shall come, the Ecclesiastical Commissioners for England send greeting.

**WHEREAS** a new church has lately been built within the parish of Llangammarch, in the county of Brecknock and in the diocese of Saint David's, and has been consecrated and is known as the Church of Saint Cadmarch:

And whereas the Right Reverend John, Bishop of the said diocese of Saint David's, as such Bishop and also as the Patron, in right of his See, of the vicarage of the said parish

of Llangammarch, and the Reverend John Evans, Clerk in Holy Orders, as the Vicar or Incumbent of the said vicarage of Llangammarch, have by an Instrument under their hands, bearing date on or about the nineteenth day of July, in the year one thousand nine hundred and sixteen, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said parish of Llangammarch that the said new Church of Saint Cadmarch, situate within such parish, should be substituted for the old parish church (also known as the Church of Saint Cadmarch) of the same parish:

Now therefore, we, the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do by this Instrument under our common seal, with the consent (testified as hereinafter mentioned) of the said John, Bishop of Saint David's, and of the said John Evans, hereby declare that the said new Church of Saint Cadmarch, situate within the said parish of Llangammarch and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church of the same parish, and that such new church shall henceforth be the parish church of the said parish of Llangammarch in lieu of the said old parish church of the same parish as fully in all respects as if the said new Church of Saint Cadmarch so hereby substituted, had been originally the parish church of the same parish:

And we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old parish church of the said parish of Llangammarch or of or belonging to the Vicar or Incumbent thereof, to the said new Church of Saint Cadmarch (now being by virtue of these presents the parish church of the said parish of Llangammarch), and to the Vicar or Incumbent thereof and his successors for ever.

In witness whereof to these presents we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said John, Bishop of Saint David's, has set his hand and affixed his episcopal seal, and the said John Evans has set his hand and affixed his seal, this twenty-seventh day of July, in the year one thousand nine hundred and sixteen.
