

Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the Consecrated Church of Saint Andrew, Nether Hoyland, situate in the Parochial Chapelry of Nether Hoyland, in the County of York, and in the Diocese of Sheffield:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Andrew, Nether Hoyland, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Leonard Hedley, Bishop of Sheffield, (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would in our opinion be expedient that all that part of the said Parochial Chapelry of Nether Hoyland which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the Map or Plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Andrew, Nether Hoyland, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Andrew, Nether Hoyland.'

"And with the like consent of the said Leonard Hedley, Bishop of Sheffield, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, Churchings, and burials should be solemnised or performed at the said Church of Saint Andrew, Nether Hoyland, situate as aforesaid, and that the fees to be received in respect of the publication of such banns, and of the solemnisation or performance of the said offices, should be paid and belong to the Minister of the same Church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal Consideration, and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Andrew, Nether Hoyland, being:—

"All that part of the Parochial Chapelry of Nether Hoyland, in the County of York, and in the Diocese of Sheffield, which is bounded upon the east by the Particular District of the Holy Trinity, Elsecar, upon the north-east partly by the New Parish of Saint Mary, Wombwell, and partly by the Parochial Chapelry of Worsborough, all in the said County and Diocese, upon the north-west by the said Parochial Chapelry of Worsborough, and upon the remaining side, that is to say, upon the south-west, by an imaginary line commencing upon the boundary which divides the

said Parochial Chapelry of Worsborough from the said Parochial Chapelry of Nether Hoyland at the centre of the bridge which carries the bridle path leading from Worsborough to Upper Hoyland across the stream known as Short Wood Dike, and extending thence first south-westward, and then south-eastward, along the middle of the said bridle path for a distance of 17 chains or thereabouts to the point in the middle of the bridge where the Hoyland Silkstone Branch Line of the Great Central Railway crosses the said roadway, and extending thence first north-eastward, and then south-eastward, along the middle of the said Line of Railway for a distance of 56 chains or thereabouts to the centre of the bridge which carries the footpath leading into Hawshaw Lane near Hawshaw Farm across the said Line of Railway, and extending thence first south-westward, and then southward, along the middle of the said footpath for a distance of 19 chains or thereabouts to its junction with Hawshaw Lane, and extending thence eastward along the middle of Hawshaw Lane for a distance of 12 chains or thereabouts to its junction with the footpath leading into West Street, and extending thence south-eastward along the middle of such footpath for a distance of 28 chains or thereabouts to its junction with West Street, and extending thence westward along the middle of West Street for a distance of 8 chains or thereabouts to its junction with the roadway running along the western side of the premises attached to the Roman Catholic Chapel and Presbytery, and extending thence southward along the middle of such roadway for a distance of 6 chains or thereabouts to its southern end opposite to the fence forming the southern boundary of the close numbered 1 upon the Map or Plan annexed to this Representation, and extending thence first eastward to and along the said fence, and then first southward, then south-eastward, then south-westward, and then westward, along the fences forming the western boundaries of the closes numbered 2 and 3 and the northern boundaries of the closes numbered 4, 5 and 6 upon the said Map or Plan for a distance in all of 45 chains or thereabouts to the point where the fence forming the northern boundary of the said close numbered 6 meets the eastern side of the footpath leading into Kitty Hague Lane, and extending thence first westward to the middle of such footpath, and then south-eastward along the middle of the said footpath, and along the middle of Kitty Hague Lane, for a distance in all of 25 chains or thereabouts to the junction of such lane with the footpath leading to Broad Car Road and Burying Lane, and extending thence south-eastward along the middle of the last-mentioned footpath for a distance of 8 chains or thereabouts to its junction with Broad Car Road and Burying Lane, and extending thence south-eastward along the middle of Burying Lane for a distance of 40 chains or thereabouts to the boundary which divides the said Parochial Chapelry of Nether Hoyland from the said Particular District of the Holy Trinity, Elsecar."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and
