THE INSPECTORS' (UNEMPLOYMENT INSURANCE) REGULATIONS, 1916.

The Board of Trade, in pursuance of the powers conferred on them by the National Insurance (Unemployment) Acts, 1911-1916, hereby make the following Regulations:—

(1) Any certificate of appointment furnished after the date of these Regulations under sub-section (5) of Section 112 of the National Insurance Act, 1911, to an Inspector appointed for the purposes of the National Insurance (Unemployment) Acts, 1911-1916, shall be in the form set out in the Schedule to these Regulations.

SCHEDULE.

Form of Certificate of Appointment of Inspector.

National Insurance (Unemployment) Acts, 1911-1916.

The Board of Trade hereby certify that, whose usual signature appears in the margin hereof, has been duly appointed an Inspector for the purpose of the said Acts, and as such Inspector to do all such things as by virtue of the said Acts an Inspector has power to do for the purposes of

the execution of the said Acts. This appointment shall continue in force so long as the Board of Trade think fit and no longer.
