reference to the said States, unless the context otherwise requires:—

"The Governor" means the Officer for the time being exercising the functions:—

(a) As regards the Federated Malay States, of British Resident of the State in or on his way to which the Fugitive is or is suspected of being;

(b) As regards Johore, of General Adviser;

- (c) As regards Kedah, Perlis and Kelantan, of British Adviser;
- (d) As regards Brunei, of British Resident;
- (e) As regards North Borneo, of Principal Representative of the British North Borneo Company in Borneo.
- (ii) The Fugitive Offenders Act, 1881, shall apply to the Federated Malay States as though they were one British Possession, and one part of His Majesty's Dominions.

4. Part II of the Fugitive Offenders Act, 1881, shall apply to the Colony and the States named in the Schedule to this Order.

5. The Straits Settlements Extradition Order, 1889, so far as it applies to any of the States named in the Schedule to this Order, but not further or otherwise, the Straits Settlements Extradition Order, 1901, the Straits Settlements Extradition Order, 1908, and the Straits Settlements Fugitive Offenders Order, 1904, shall, as from the commencement of this Order, be revoked, without prejudice to anything lawfully done thereunder or to any proceedings commenced before the commencement of this Order.

And the Right Honourable Andrew Bonar Law, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 12th day of October, in the year 1916, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter

55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the Consecrated Church of All Saints, Bedford, situate in the Parish of Saint Paul, Bedford, in the County of Bedford, and in the Diocese of Saint Albans:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of All Saints, Bedford, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Edgar, Bishop of Saint Albans, (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said Parish of Saint Paul, Bedford, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the Map or Plan hereunto annexed, should be assigned as a District Chapelry to the said Church of All Saints, Bedford, situate as aforesaid, and that the same should be named 'The District Chapelry of All Saints, Bedford.'

"And with the like consent of the said Edgar, Bishop of Saint Albans, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of All Saints, Bedford, situate as aforesaid, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices, should be paid and belong to the Minister of the same Church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal Consideration, and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of All Saints, Bedford, being: —

"All that part of the Parish of Saint Paul, Bedford, in the County of Bedford, and in the Diocese of Saint Albans, which is bounded upon the south partly by the New Parish of Saint Leonard, Bedford, and partly by the Parish of Kempston, upon the west by the Parish of Biddenham, upon the north and upon the north-east by the New Parish of the Holy Trinity, Bedford, all in the said County and Diocese, and upon the remaining side, that is to say, upon the east, by an imaginary line commencing upon the boundary which divides the said New Parish of the Holy Trinity, Bedford, from the said Parish of Saint Paul, Bedford, at the centre of the bridge which lies to the south-east of Bedford Railway Station, and which carries Ford End Road across the main line of the Midland Railway, and extending thence first south-eastward, and then southward, along the middle of the said line
