forming the northern boundary of the Newton Gas Works, and extending thence first eastward to and along the said wall, and then southward along the wall forming the eastern boundary of the said Gas Works, for a distance in all of 9 chains or thereabouts to the point where the last-mentioned wall meets the wall at the eastern end of the roadway running between the said Gas Works and the West Lancashire Flint Glass Works, and extending thence southward along the last-mentioned wall, along the wall forming the eastern boundary of the said Glass Works, and along the wall in continuation thereof for a distance in all of 3 chains or thereabouts to the wall at the northern end of Water Street, and extend-ing thence first eastward to, and then south-ward along, the middle of Water Street for a distance of 5 chains or thereabouts to its junction with Crow Lane East and Victoria Road, and extending thence south-eastward along the middle of Victoria Road for a distance of 22 chains or thereabouts to its junction with Wargrave Road, and extending thence south-eastward along the middle of Wargrave Road for a distance of 2 chains or thereabouts to the northern side of the bridge which carries the Liverpool and Manchester Line of the London and North Western Railway across such road, upon the boundary which divides the said New Parish of Saint Peter, Newton-in-Makerfield, from the said Parish of Newton-in-Maker-field."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Liverpool.

WHEREAS the Local Government Board, after giving to the Incumbent and the Churchwardens of the Parish of Cenarth, in the County of Carmarthen, 10 days' previous Notice of their intention in that behalf, have, under the provisions of the Burial Act, 1853. as amended by the Burial Act, 1900, made a Representation to His Majesty in Council that, for the protection of the public health, the opening of any new Burial Ground in the Civil Parish of Cenarth, in the County of Carmarthen, save with the previous approval of the Local Government Board, should be prohibited, and that Burials should be discontinued therein, as follows, viz.:—

CENARTH.—Forthwith and entirely in the Church of St. Llawddog, Cenarth, in the County of Carmarthen, and in the Churchyard attached thereto: Provided that

(a) In any walled grave now existing in the said Churchyard burial may be allowed subject to the condition that every coffin buried in such grave be separately enclosed by stonework or brickwork properly cemented.

(b) In any earthen grave now existing in the said Churchyard the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than 3 feet below the level of the surface of the ground adjoining the grave.

Now, therefore, His Majesty in Council is pleased hereby to give Notice of such Representation, and to order that the same be taken into consideration by a Committee of the Privy Council on the 5th day of December next.

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 5th day of December.

W HEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State, such List as so varied or added to being in the last mentioned Proclamation referred to as the "Statutory List":

And whereas the List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect:—

That the "Statutory List" of persons and bodies of persons, incorporated or unincorporated, with whom trading is prohibited, should be further varied in respect of the name set forth in the Schedule hereto:

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.
