

with the advice of His Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to His Majesty, with such advice as aforesaid, may seem fit

And whereas Her Majesty Queen Victoria was pleased, by Her Order in Council of the 14th day of July, 1899, to direct (amongst other things) the discontinuance of burials, with certain exceptions, in the Parish Church of Hollinwood, in the Borough of Oldham and County of Lancaster, and also in the Churchyard:

And whereas it seems fit to His Majesty, by and with the advice of His Privy Council, that the said Order in Council, so far as it relates to burials in the said Parish Churchyard of Hollinwood aforesaid, should be varied

Now, therefore, His Majesty, by and with the advice aforesaid, is pleased to order, as it is hereby ordered, that the said Order in Council of the 14th day of July, 1899, so far as it relates to burials in the Parish Churchyard of Hollinwood, in the Borough of Oldham and County of Lancaster, be and the same is hereby varied so that, notwithstanding anything therein, it shall be lawful to bury the body of Isaac Prockter, at his decease, in a vault to be constructed in the said Churchyard, provided that the coffin shall be separately enclosed by stonework or brickwork properly cemented

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Exten-

sion of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation.

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State, such List as so varied or added to being in the last mentioned Proclamation referred to as the "Statutory List"

And whereas the List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect:—

That the "Statutory List" of persons and bodies of persons, incorporated or unincorporated, with whom trading is prohibited, should be further varied in respect of the name set forth in the Schedule hereto

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Right Honourable Viscount Grey, K.G., one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
