NATIONAL INSURANCE ACTS, 1911 to

Notice is hereby given, pursuant to the provisions of Section 113 of, and the Ninth Schedule to, the National Insurance Act, 1911, that the National Health Insurance Joint Committee propose to make a Special Order under Section 25 of the National Insurance Act, 1913, declaring that—

- 1. the provisions of the National Health Insurance (Normal Rate of Remuneration) Order, 1914, shall cease to apply to the following class of work specified in the Schedule to that Order:—
- "Shirt-making in the City of Man-chester";
- 2. female outworkers employed in England and Wales by any employer in the making of boxes or parts thereof made wholly or partially of paper, cardboard, chip, or similar material, shall, for the purposes of the National Insurance Act, 1911, be treated as if they were constantly in receipt of a rate of remuneration exceeding 2s. but not exceeding 2s. 6d., and the National Health
