(4) Any order of the Board of Trade under this regulation may be revoked or varied as occasion requires.

3. In Regulation 39A for the opening words down to and including the words "requisitioned by the Army Council" the following words shall be substituted: "If a person lawfully engaged to serve on board any ship or vessel belonging to or chartered, hired, or requisitioned by the Admiralty or Army Council."

At the end of the same Regulation the following words shall be inserted:—

"and for the purposes of this regulation a copy of any entry made in an official log book in manner provided by the Merchant Shipping Act, 1894, shall, if it purports to be signed and certified as a true copy or extract by the officer in whose custody the original log book is entrusted, be admissible in evidence."

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 9th day of November, in the year 1916, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Saint Michael and All Angels, Bedford Park, and of the New Parish of Saint Peter, Acton Green, both in the County of Middlesex, and in the Diocese of London:

"Whereas by the authority of an Order of Her said late Majesty in Council, bearing date the 28th day of October, in the year 1879, and published in the London Gazette on the 31st day of the same month, certain portions of the Parish of Chiswick, of the New Parish of All Saints, South Acton, and of the New Parish of Saint George, Old Brentford, all in the said County of Middlesex, and in the said Diocese of London, were constituted a Separate District for spiritual purposes, and such District was named 'The District of Saint Michael and All Angels, Bedford Park':

"And whereas by the authority of an Order of Your Majesty in Council, bearing date the 2nd day of June, in the year 1915, and published in the London Gazette on the 8th day of the same month, a Consolidated Chapelry

was assigned to the Consecrated Church of Saint Peter, Acton Green, situate within the said New Parish of All Saints, South Acton, and such Consolidated Chapelry was named 'The Consolidated Chapelry of Saint Peter, Acton Green':

"And whereas the said District of Saint Michael and All Angels, Bedford Park, and the said Consolidated Chapelry of Saint Peter, Acton Green, have become New Parishes of the character contemplated by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, by the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, and by the above-mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us, and it appears to us to be expedient, that the boundaries of the said New Parish of Saint Michael and All Angels, Bedford Park, and of the said New Parish of Saint Peter, Acton Green, should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Honourable and Right Reverend Arthur Foley, Bishop of London, (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend, and propose, that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation, and without any assurance in the law other than such duly gazetted Order, the boundaries of the said New Parish of Saint Michael and All Angels, Bedford Park, and of the said New Parish of Saint Peter, Acton Green, shall be altered so that all that portion of the said New Parish of Saint Peter, Acton Green, which is described in the Schedule hereunder written, and is delineated and set forth upon the Map or Plan hereunto annexed, and is thereon coloured *pink*, shall be dissevered from such New Parish, and shall be annexed to, and shall in future form part of, the said New Parish of Saint Michael and All Angels, Bedford Park.

"And we further represent, recommend, and propose, that nothing herein contained shall prevent us from representing, recommending, and proposing, any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore-mentioned Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be dissevered from the New Parish of Saint Peter, Acton Green, in the County of Middlesex, and in the Diocese of London, and to be annexed to the New Parish of Saint Michael and All Angels, Bedford Park, in the same County and Diocese, being:—

"All that portion of the said New Parish of Saint Peter, Acton Green, which is bounded upon part of the east, and upon the south, by the said New Parish of Saint Michael and All Angels, Bedford Park, and upon the remaining sides, that is to say, upon the west, upon the north, and upon the remaining part of the east, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Michael and All Angels, Bed-
