So much of Wolverhampton Road as extends from a point in the road 26 yards south of the southern end of the parapet of the Bull Bridge to a point 50 yards south of the southern entrance to the Cattle Market;

So much of Cannock Road as extends from its two junctions in and near The Square with the Wolverhampton Road to a point in the road 5 yards east of the eastern entrance to Reynard Cottage;

So much of Acton Lane (otherwise known as Teddsley Road) as extends from its junction with the Cannock Road opposite the Fire Station to a point in the road 75 yards north-east of its junction with the bye-road leading to the Schools;

So much of Cuttlestone Lane (otherwise known as Cattlestone Lane) as extends from its junction with the Wolverhampton Road to a point in the road 100 yards east of the entrance to the Vicarage.

2. So much of the Road leading out of the said main road at or near the Ty Fry Inn, to its junction with the main road from Abergele to Rhuddlan, as extends from a point in the road 460 yards north of Canolblas Farm buildings to its junction with the first-mentioned main road.
