For Male Workers of 16 and under 17 years of age, from 9s. to 10s. per week.

10. For Male Workers of 15 and under 16 years of age, from 7s. 6d. to 8s. per week.

11. For Male Workers under 15 years of age, from 6s. to 6s. 6d. per week.

The above Proposals are on the basis of a week of 52 hours, the rates being subject to a proportionate deduction or increase according as the number of hours actually spent by the worker in the factory or workshop under contract of employment in any week is less or more than 52.

No Variation is proposed in respect of the of the above-mentioned other Provisions Notices issued by the Trade Board, dated the 7th June, 1915, and the 14th August, 1916.

The KING has been graciously pleased to confer the Decoration of the Albert Medal of the Second Class upon Mr. Joseph Conolly, Third Engineer of the steamship "Vanellus," of Cork.

The following is an account of the services in respect of which the Decoration has been con-

On the 1st October, 1916, the steamship Vanellus," of Cork, struck a mine in Havre Roads, and the vessel, which was laden with petrol, immediately burst into flames.

Owing to the rapidity with which the flames spread it was impossible to clear away the boats, and most of the crew jumped overboard. Three lives were lost by the casualty.

Although the engine-room telegraph was broken by the explosion Mr. Conolly remained at his post in the engine-room until everyone else had left the ship. He kept the engines working astern, and thus made it possible for a lifeboat to be lowered on the port side, and by this means a number of lives were saved.

Before finally leaving the ship he again went

below and stopped the engines.

Mr. Conolly was badly burnt in rendering the services.
