ORDER OF THE BOARD OF REFEREES.

The Thermo-Electric Ore Reduction Corporation, Limited, whose registered office is at York Street, Luton, in the county of Bedford, having made application under this Act to the Commissioners of Inland Revenue for an increase of the statutory percentage as respects the class of trade or business hereinafter defined, that is to say:

"The business of manufacturing and preparing tungsten, molybdenum, chromium, tantalum, vanadium, and their alloys so far as the same are used in the manufacture of high-speed steel"
