ORDER (FURTHER AMENDMENT) OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE WESTERN BORDER AREA.

We, the Central Control Board (Liquor Traffic), in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order:—

1. This Order shall apply to so much of the Western Border Area as comprises the Counties of Kirkcudbright and Dumfries, including all Burghs within the geographical limits thereof, the Parishes of Castleton and Teviothead in the County of Roxburgh, the City of Carlisle, the Petty Sessional Divisions of Longtown, Cumberland Ward and Brampton, so much of the Parishes of Hesket in the Forest and
