ARMY COUNCIL ORDER.

DEFENCE OF THE REALM REGULATIONS.

REGULATION OF THE SALE OF HAY AND OAT AND . WHEAT STRAW IN GREAT BRITAIN.

Whereas by Order of the 5th November, 1916, the Army Council in pursuance of the

powers conferred on them by the Defence of the Realm (Consolidation) Regulations, 1914-1916, did regulate the price of hay and oat and wheat straw in Great Britain and Ireland and the Isle of Man.

And whereas it is desired to amend the said Order of the 5th November, 1916, in so far as it relates to Great Britain.

Now, therefore, in pursuance of the powers conferred on them by the Defence of the Realm Regulations and all other powers thereunto enabling them, the Army Council hereby cancel so much of the said Order of the 5th November, 1916, as relates to the sale of hay and oat and wheat straw in Great Britain, and hereby order:—

That on any sale of hay or oat straw or wheat straw in Great Britain, the price shall not exceed such prices as are set out in the Schedules hereunder:—

The above prices are deemed to include the price of carting to nearest Railway Station, but not the cost of cutting, trussing, tying or baling, or chaffing or chopping.
