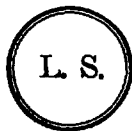

SPECIAL ACTS (EXTENSION OF TIME) ACT, 1915.

BY virtue and in exercise of the powers conferred upon them by the Special Acts (Extension of Time) Act, 1915, the Board of Trade hereby order that the time limited by the Great Eastern Railway Act, 1912, as extended by the Great Eastern Railway Act, 1915, (a) for the compulsory purchase of lands to be acquired by the Great Eastern Railway Company (hereinafter referred to as "the Company"), for the construction of the following works described in and authorised by section 6 (subsections (A) (C) (D) (E) (F1) and (F2) of the said Act of 1912, viz.:—

(1) The widenings and improvements Nos. 1 and 2 of the Company's Norwich to Cromer Line of Railway;

(2) the widenings and improvements Nos. 4, 5, 6, and 7 of the Company's Felixstowe Branch Railway;

(3) the widening and improvement No. 8 of the Company's Ely and Newmarket Branch Railway;

(4) the widening and improvement No. 9 of the Company's Cambridge Main Line.

(5) the deviations and improvements Nos. 1 and 2 of the Company's Beccles to Yarmouth Line, with the swing bridges for carrying the deviated railways over the River Waveney;

and (b) for the compulsory purchase of the lands at Chatteris Dock, authorised to be acquired by and described in section 31 of the said Act of 1912 shall be extended for one year from the 7th day of August, 1917.
