PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the 3rd, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 28th day of June, in the year 1917, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the Consecrated Church of Saint John the Baptist, Knighton, situate in the New Parish (sometime District Chapelry) of Saint Mary Magdalen, Knighton, in the County of Leicester, and in the Diocese of Peterborough:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint John the Baptist, Knighton, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Frank Theodore, Bishop of Peterborough, (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would in our opinion be expedient that all that part of the said New Parish of Saint Mary Magdalen, Knighton, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the *Map* or *Plan* hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint John the Baptist, Knighton, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint John the Baptist, Knighton.'

"And with the like consent of the said Frank Theodore, Bishop of Peterborough, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint John the Baptist, Knighton, situate as aforesaid, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices, should be paid and belong to the Minister of the same Church for the time being: Provided always that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the

performance of the said office of baptism, or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal Consideration, and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"THE SCHEDULE TO WHICH THE FOREGOING REPRESENTATION HAS REFERENCE.

"The District Chapelry of Saint John the Baptist, Knighton, being:—

"All that part of the New Parish (sometime District Chapelry) of Saint Mary Magdalen, Knighton, in the County of Leicester, and in the Diocese of Peterborough, which is bounded upon the north-east by the New Parish of Saint Philip, Leicester, upon the north-west partly by the New Parish of Saint Peter, Leicester, and partly by the New Parish of All Souls, Leicester, upon the west by the Parish of Saint James, Aylestone Park, all in the said County and Diocese, and upon the remaining sides, that is to say, upon the south-west and upon the south-east by an imaginary line commencing upon the boundary which divides the said Parish of Saint James, Aylestone Park, from the said New Parish of Saint Mary Magdalen, Knighton, at a point on the western side of Saffron Lane opposite to the middle of Knighton Lane, and extending thence first eastward to, and then first south-eastward, then eastward, and then north-eastward along the middle of Knighton Lane for a distance of 53½ chains or thereabouts to its junction with Welford Road, and extending thence north-westward along the middle of Welford Road for a distance of 19½ chains or thereabouts to its junction with Knighton Fields Road East, and extending thence eastward along the course of the proposed new road named 'Houlditch Road' for a distance of 25½ chains or thereabouts to a point in the middle of the footpath leading from the old Village of Knighton to Queen's Road, and extending thence northward along the middle of the said footpath, and along the middle of Queen's Road, for a distance in all of 18 chains or thereabouts to a point opposite to the western end of the wall or fence forming the southern boundary of the house and premises known as Number 192, Queen's Road, and extending thence eastward in a straight line for a distance of 21 chains to a point in the middle of the wall or fence at the present western end of Toller Road, and extending thence north-eastward along the middle of Toller Road for a distance of 11 chains or thereabouts to its junction with London Road, and extending thence south-eastward along the middle of London Road for a distance of 2½ chains or thereabouts to its junction with Sandown Road, and extending thence north-eastward along the middle of Sandown Road for a distance of 11 chains or thereabouts to its junction with Stoneygate Road, and extending thence south-eastward along the middle of Stoneygate Road for a distance of 6 chains or thereabouts to its junction with the road leading past the north-western side of the house and premises known as The Home, and extending thence north-eastward along the middle of the last-mentioned road for a distance of 9 chains or thereabouts to its present north-eastern end, and continuing thence north-eastward in, precisely the
