empowered, by Instrument or Instruments in writing duly executed according to law, from time to time to sell or dispose of and duly to convey, according to the provisions of the said Act, all or any of the said lands tenements and hereditaments, so vested in us as aforesaid, under and by virtue of the said Indentures or either of them, with their appurtenances, and all our estate, right, title and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs, executors, administrators, or assigns, or otherwise as he or they shall direct or appoint, and for such consideration as shall upon due calculation and inquiry appear to us to be just and reasonable, it being our intention to invest the proceeds of such sale from time to time as

occasion may arise in the purchase of other lands, tithes, rentcharges, tenements, or hereditaments, or of some estate or interest therein convenient to be held by us for the purposes of the Acts by which our proceedings are governed as aforesaid, and in the meantime to invest the said proceeds in some Government or Parliamentary Stock or other Public Securities in England.

"And we further recommend and propose that nothing herein contained shall prevent ufrom recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parlia-

ment.

"All which we humbly recommend and propose to Your Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid

before His Majesty in Council, a Representation, bearing date the 14th day of June, in the year 1917, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a Consolidated Chapelry to the Consecrated Church of Saint Matthew, Grangetown, situate within the Parish of Eston, in the County of York, and in the Diocese of York:

"Whereas at certain extremities of the said Parish of Eston, and of the Parish of Wilton, in the said County and Diocese, which said extremities lies contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several Churches of such Parishes:
