The Certificate, which bears date the 29th September, 1917, provides that the number of boys resident in the School at any one time, whether sent thereto in pursuance of the said provisions or not, shall not exceed sixty-one.

**TIMBER: CONTROL OF TEAK AND  
LIGNUM VITÆ.**

In pursuance of the powers conferred upon them by The Defence of the Realm Regulations, the Board of Trade hereby order that as from the 5th October, 1917, until further notice, no person shall sell or purchase in the United Kingdom any timber of the following descriptions, namely:—

(a) Teak Logs, Planks, Boards and Decking.

(b) *Lignum Vitæ.*

except under licence or permit issued by or on behalf of the Board of Trade, but no licence or permit will be required for the purchase or sale of Teak Logs, Planks or Boards, where the aggregate value thereof purchased, or sold, does not exceed £50 per calendar month.
