in exercise of the powers in this behalf by "The Foreign Jurisdiction Act, 1890," or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:-

1. This Order may be cited as "The China (Control of Shipbuilding) Order in Council, 1918," and shall be read as one with "The China Order in Council, 1904" (hereinafter called the "Principal Order"), and with any

Order amending the same.

2. It shall not be lawful for any person to lay down, build, or construct, or to direct or assist in the laying down, building, or construction of a ship within the limits of the Principal Order without the previous consent in writing of the Minister, provided that this Article shall not apply to the completion of a ship which was actually under construction at the date of the

making of this Order.

3. If any person lays down, builds, or constructs, or directs, or assists in the laying down, building, or construction of a ship in contravention of this Order, the ship, or part of a ship, so laid down or constructed shall be forfeited to the Crown, and the person so acting in contravention of this Order shall be liable to imprisonment, without hard labour, not exceeding six months, and to a fine not exceeding 500 dollars for every day during which such contra-vention continues; and, if such person be a company, every director and officer of the company shall be liable to the like penalty, unless he proves that the contravention took place without his knowledge or consent.

4. This Order shall come into force on the

1st day of March, 1918.

## CARGOES EX ENEMY VESSELS IN PORTUGUESE HARBOURS.

With reference to the notification which was published in the London Gazette of the 11th ult. respecting the release of Allied and neutral merchandise found on enemy vessels in Portuguese harbours, a translation is now appended of the Portuguese Decree referred to therein:-

DECREE No. 3745, January 3rd, 1918.

Having taken into consideration the representations made to me by the Ministers of all the Departments, I hereby decree, to have the force of law, as follows:—

#### ARTICLE 1.

The period for the presentation of any claim for the delivery of the goods referred to in.
Article 32 of the Decree of the 20th of April, 1916,\* is hereby extended to the 28th of February, 1918.

## ARTICLE II.

The production of documents in support of . fresh claims or of claims previously sent in, will only be admitted within the period laid down in the preceding Article.

#### ARTICLE III.

The provisions of Article 2 of the Decree No. 3246 of the 13th of July, 1917, intended to simplify the regular procedure by the production of Legation certificates, shall be applicable to all claims for goods made within the period fixed by Article I. of the present Decree, provided the certificates are presented within the said period.
