in or in respect of which the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say in the Parishes of Caundle Purse and Caundle Stourton :

"Now, therefore, with the consent of the said Sir Henry Hugh Arthur Hoare (in testimony whereof he has signed and sealed this Scheme) and with the consent of the said Dame Alda Annie Hoare (in testimony whereof she has signed and sealed this Scheme) and with the consent of the said Frederic Edward, Bishop of Salisbury, (in testimony whereof he has signed this Scheme, and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to each of the said Benefices of Caundle Purse and Caundle Stourton, or (as the case may be) of the said United Benefice, now vested in him, the said Sir Henry Hugh Arthur Hoare as aforesaid, shall be transferred to the said Frederic Edward, Bishop of Salisbury, and his Successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said Frederic Edward, Bishop of Salisbury, and his Successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.'

And whereas the said Scheme has been ap-

proved by His Majesty in Council: Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Salisbury.

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Peter, Bardon Hill, situate as aforesaid :

"Now, therefore, with the consent of the Right Reverend Frank Theodore, Bishop of Peterborough, (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said Parish of Hugglescote with Donington, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the Map or Plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Peter, Bardon Hill, situate as aforesaid, and that the same should be named 'The District

Chapelry of Saint Peter, Bardon Hill': "And with the like consent of the said Frank Theodore, Bishop of Peterborough, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that īt appears to us to be expedient that banns of matrimony should be published, and that marbaptisms, churchings, and burials, riages, should be solemnized or performed at the "aid Church of Saint Peter, Bardon Hill, situate as aforesaid, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices, should be paid and belong to the Minister of the same Church for the time being; Provided always that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal Consideration, and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.
