

Municipal Corporations Acts and other Acts in their application to the borough.

To make all necessary or proper provision with regard to the election and appointment of guardians on the Board of Guardians of the West Bromwich Union and overseers of the poor and the allocation of such guardians for the purposes of such election, and otherwise to or among the new wards to be constituted under the intended Act, and to make any incidental or consequential provision with reference to such matters.

To vary or extinguish all or any rights and privileges inconsistent with or which would or might in any way interfere with the objects of the intended Act and to confer other rights and privileges.

To empower the Corporation to borrow the moneys required for the payment of the costs, charges and expenses of and incidental to the intended Act and consequential provisions.

To alter, amend, extend, enlarge, repeal, incorporate or re-enact with or without amendment all or some of the provisions of the West Bromwich Improvement Act, 1876, the West Bromwich Corporation Act, 1900, and all other Acts and Orders relating to the Corporation or to the Borough or any part thereof.

Printed copies of the Bill for the intended Act will be deposited in the Private Bill Office of the House of Commons as soon as leave shall have been given by Parliament to introduce the Bill.

NEWQUAY ELECTRIC LIGHT AND POWER.

(Application by the Newquay Electric Light and Power Company Limited to the Board of Trade to vary Provisional Orders granted by the Board of Trade under the Electric Lighting Acts, 1882, 1888 and 1909, in respect of the Urban District of Newquay, in the County of Cornwall.)

NOTICE is hereby given, that the Newquay Electric Light and Power Company Limited, whose registered office is at 66, Victoria Street, London, S.W. (hereinafter called "the Undertakers"), intend to apply to the Board of Trade on or before the 18th day of April, 1918, for a Provisional Order (hereinafter called "the Order"), under the Electric

Lighting Acts, 1882 to 1909, varying the Provisional Order granted by the Board of Trade under the Electric Lighting Acts, 1882 and 1888, to Henry Foote, Leonard Milne and Edward John Owen in 1904 and transferred to the Undertakers, to produce, store, supply, sell and distribute electricity within the urban district of Newquay, in the county of Cornwall, and another Order of the Board of Trade, dated the 22nd day of March, 1916, whereby the Board of Trade, by virtue and in exercise of the powers conferred on them by Section 32 of the Schedule to the Electric Lighting (Clauses) Act, 1899, varied the maximum prices stated in the said Provisional Order and substituted the following maximum prices, that is to say:—For any amount up to 17 units, 9s. 11d., and for each unit over 17 units sevenpence, and the Board of Trade further ordered that the said prices should have effect on and after the 26th day of March, 1916, in the manner and to the effect following (that is to say):—

That the maximum prices stated in the Provisional Order as varied by the said Order of the 22nd day of March, 1916, which may be charged by the Undertakers shall be varied, and that the following maximum prices shall be substituted therefor (that is to say):—For any amount up to twelve units, ten shillings, and for each unit over twelve, ten pence.

That the period of revision of maximum price and allowing representations as to revision to be made by consumers by Section 10 of the Electric Lighting Act, 1909, shall for the purpose of incorporation with this Order be read as if the words "one year" were substituted for the words "five years."

And notice is hereby given, that printed copies of the draft Provisional Order will be deposited at the Board of Trade on or before the 18th day of April next, and printed copies thereof when deposited and of the Order when made may be obtained at the offices of the undersigned Solicitors and at the offices of the Company at the Electricity Works at Newquay at the price of one shilling each copy.

And notice is hereby given, that every local or other public authority, company or person desirous of making any representation to the Board of Trade or of bringing before them any objection respecting this application must do so by letter addressed to the Board of Trade, marked on the outside of the cover enclosing it "Electric Lighting Acts," on or before the 18th day of April, 1918, and a copy of such objection must also be forwarded to the Solicitors for the Order.
