upon all sides as follows, that is to say:—upon the north by the said New Parish of West Pinchbeck, upon the east and upon the southeast by the New Parish of Saint John the Baptist, Spalding, in the said County and Diocese, upon the south and upon the south-west by the said Particular District of Saint Nicholas, Deeping Fen, and upon the northwest by the above described detached portion of the Parish of Spalding.

And whereas Drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation, and such Patrons and Incumbents have respec-

tively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar

of the said Diocese of Lincoln.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 28th day of February, 1918, in the words and figures fol-

lowing, that is to say:—
"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Saint John, Levens, and the New Parish of Saint Paul, Witherslack, both in the County of Westmorland, and in the Diocese of Carlisle:

"Whereas by the authority of an Instrument bearing date the 19th day of June, 1838, and being under the Common Seal of the late Commissioners for building New Churches, and under the hand and seal of the late Right Honourable and Most Reverend John Bird, sometime Archbishop of Canterbury, who at that time was Bishop of Chester, certain parts of the Parish of Heversham, in the said County of Westmorland, and, at that time, in the Diocese of Chester, but now in the said Diocese of Carlisle, were assigned as a Particular District to the Consecrated Church of Saint John the Evangelist, situate at Levens, in the said Parish of Heversham, and the said Particular District was known as 'The Particular District of Saint John, Levens':

"And whereas by the authority of an Order of Her said late Majesty in Council, bearing date the 20th day of March, 1891, and published in the London Gazette on the 24th day of the same month, a part of the Parish of Beetham, in the said County of Westmorland, and in the said Diocese of Carlisle, was assigned as a District Chapelry to the Consecrated Church of Saint Paul, Witherslack, situate within the limits of the Ancient Chapelry of Witherslack, in the said Parish of Beetham, and the said District Chapelry was called 'The District Chapelry of Saint Paul, Witherslack':

"And whereas the said Particular District of Saint John, Levens, and the said District Chapelry of Saint Paul, Witherslack, have, under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become New Parishes of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above-mentioned Act of the 32nd and 33rd years of Her said late

Majesty, Chapter 94:

'And whereas it has been represented to us, and it appears to us to be expedient, that the boundaries of the said New Parish of Saint John, Levens, and the said New Parish of Saint Paul, Witherslack, should be altered in

the manner which is hereinafter mentioned:
"Now, therefore, with the consent of the Right Reverend John William, Bishop of Carlisle, (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend, and propose, that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation, and without any assurance in the law other than such duly Gazetted Order, the boundaries of the said New Parish of Saint John, Levens, and the said New Parish of Saint Paul, Witherslack, shall be altered so that all that detached porof the said New Parish of Saint John, Levens, which is described in the Schedule hereunder written, and is delineated and set forth upon the Map or Plan hereunto annexed, and is thereon coloured pink, shall be dissevered from such New Parish, and shall be annexed to and shall in future form part of the said New Parish of Saint Paul, Wither-

"And we further represent, recommend, and propose, that nothing herein contained shall prevent us from representing, recommending, and proposing, any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.
