And to all others whom it may concern.

Whereas a Scheme has been made in pursuance of the Public Health (Venereal Diseases) Regulations, 1916, by the Council of each of the Counties and County Boroughs named in the Schedule to this Order, for the gratuitous treatment of persons in the area of that County or County Borough suffering from venereal disease, and such Scheme has been approved by Us, the Local Government Board, and is now in operation:

Now, therefore, in the exercise of the powers conferred on Us by the Venereal Disease Act, 1917, We hereby Order that Section 1 of that Act shall on and after the 1st day of July, 1918, apply to the area of each of the Counties and County Boroughs named in the Schedule

This Order may be cited as "The Venereal Diseases (Berkshire, &c.) Order, 1918."

Notice.—The Venereal Disease Act, 1917, provides by sub-section (1) of section 1 that in any area in which the section is in operation, a person shall not, unless he is a duly qualified medical practitioner, for reward either direct or indirect, treat any person for venereal disease or prescribe any remedy therefor, or give any advice in connection with the treatment thereof, whether the advice is given to the person to be treated or to any other person; the Act further provides by section 3 that if any person acts in contravention of any of the provisions of the Act, he shall be liable on conviction on indictment to imprisonment, with or without hard labour, for a term not exceeding two years, or on summary conviction to a fine

not exceeding one hundred pounds, or to imprisonment, with or without hard labour, for a term not exceeding six months.
