WHEREAS by the Isle of Man (War Legislation) Act, 1914, His Majesty has power to extend to the Isle of Man any Act which, in the opinion of His Majesty, was passed for the purpose of meeting any emergency created by the present War, subject to adaptations for the purpose of making the Act applicable to the Isle of Man:

And whereas by Order in Council dated the 17th December, 1914, and subsequent Orders, His Majesty was pleased to order that the Defence of the Realm Regulations should extend to the Isle of Man, subject to the adap-

tations therein contained:
And whereas the said Reg

And whereas the said Regulations have been amended by Orders in Council of the 29th September, 1917, the 16th January, 1918, the 27th February, 1918, the 4th March, 1918, and the 22nd March, 1918:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the Regulations amending the Defence of the Realm Regulations, made by Orders of His Majesty in Council dated the 29th September, 1917, the 16th January, 1918, the 27th February, 1918, the 4th March, 1918, and the 22nd March, 1918, shall extend to the Isle of Man, subject to the following adaptations:—

In the Regulations of the 29th September, 1917.

Omit Paragraph 4.

In the Regulations of the 16th January, 1918.

Omit Paragraphs 1 and 5.

In Paragraph 2 for the words "United Kingdom," wherever the same occur, there shall be substituted the words "Isle of Man."

In the Regulations of the 27th February, 1918.

Omit Paragraphs 1, 2, and 3.

In the Regulations of the 4th March, 1918.

Omit Paragraphs 1, 2, 3, and 5.

In the Regulations of the 22nd March, 1918.

Omit Paragraph 3.

In Regulation 45r for the words "United Kingdom," wherever the same occur, there shall be substituted the words "Isle of Man," and for the words "Perjury Act, 1911, or in Scotland or Ireland at Common Law" there shall be substituted the words "Criminal Code, 1872."

In Regulation 2R, Paragraph (2), extended to the Isle of Man by Order in Council dated the 4th March, 1918, for the words "the Game Act, 1882," there shall be substituted the words "Sections 23 to 26 (both inclusive) and Sections 37 and 38 of the Game Act, 1882,"

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, subsection one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, and amended on the 16th day of January, 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the Statutory List should be further added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

That the Statutory List be added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

NOTE (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. List (The Consolidated List, No. 51A) consolidating all previous Lists, up to and including that of the 5th April, 1918, together with List No. 52 of 19th April, 1918, List No. 53 of 3rd May, 1918, List No. 54 of 17th May, 1918, and the List herewith annexed, contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of

two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway,

Note (2).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specifically mentioned.

Note (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June, and 10th November, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia. Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

Note (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, how-

ever, prepared on application to enquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of tele-graphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making enquiries would specify the particular trade or trades for which substitutes are required. General enquiries for new connections abroad should be addressed to The Comptroller-General, Department of Overseas Trade (Development and Intelligence), 73, Basinghall Street, London, E.C. 2.

(5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majestv's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M: Consul-General at New York and to other centres in the United States likely to be interested.

NOTE (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under the names commencing with descriptive terms such as "Handel Maats-chappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company) In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

THE COTTON (RESTRICTION OF OUTPUT) ORDER. 1918, DATED THE 17TH DAY OF MAY, 1918, MADE BY THE BOARD OF TRADE UNDER REGULATIONS 2F, 2G, AND 2JJ OF THE DEFENCE OF THE REALM REGULATIONS.

The Board of Trade, deeming it expedient to make further exercise of their powers under Regulations 2F and 2JJ of the Defence of the Realm Regulations, as respects cotton, hereby order as follows:—

hereby order as follows:—

1. No person shall work or cause or allow to be worked any spindles or looms in a cotton mill or weaving shed without a licence from the Cotton Control Board.

2. The Cotton Control Board may by notice exhibited in the Manchester Royal Exchange prescribe the maximum number of hours that may be worked in cotton mills or weaving sheds, and may vary such number of hours as occasion

may require.

3. A licence granted by the Cotton Control Board shall specify the number and class of spindles and the number and class of looms that may be worked in the mill or weaving shed to which it refers, and may specify the number of hours that may be worked in such mill or shed. The number of hours may be greater or less than that fixed by the notice referred to in paragraph 2 hereof, according to the number of spindles or looms licensed to be worked, the

description of cotton to be used and the nature and importance of the work on which the mill or shed is engaged.

- 4. A licence shall be for such period and subject to such conditions as to payment or otherwise as the Cotton Control Board may determine.
- 5. No person shall work or cause or allow to be worked any spindles or looms in excess of the number or for a greater number of hours than that prescribed in such licence.
- 6. The Cotton Control Board may issue instructions prescribing the number of bales of cotton or of any particular growth of cotton that may be put through the bale openers or used in any mill during any week.
- 7. The Cotton Control Board may require the occupiers of any mill to furnish a return at such times and in such form and verified in such manner as they may direct of the number of bales of all or any growths of cotton put through the bale openers or used in any mill' during any week.
- 8. The occupier of every mill or weaving shed shall on the first working day of every week exhibit in a conspicuous place in his mill or weaving shed a notice stating the number of spindles and looms and the number of hours which he is licensed to work during the week, and shall keep such notice exhibited as aforesaid during the week.
- 9. All persons shall obey such instructions as may be issued by the Cotton Control Board and make such returns as may be required by them under this Order.
- 10. No person shall knowingly make any false statement for the purpose of obtaining a licence under this Order.
- 11. The expression "person" includes a firm or other association of persons and a company. The expression "mill" includes any place where yarn or waste is spun. The expression "weaving shed" includes any place where looms are worked.
- 12. Infringements of this Order are summary offences against the Defence of the Realm Regulations.
- 13. This Order comes into effect on the 10th day of June, 1918, and as from such day the Cotton (Restriction of Output) Order, 1917, is revoked, without prejudice to any matter or thing done or suffered, penalty incurred, or proceeding instituted thereunder.
- 14. This Order may be cited as the Cotton (Restriction of Output) Order, 1918.

In exercise of the powers conferred upon them under Regulation 7s of the Defence of the Realm Regulations, the Board of Trade hereby order as follows:—

RAILWAY SEASON TICKET ORDER,

- (1) No Railway Company shall be obliged to issue Season Tickets.
 - (2) A Railway Company may refuse to issue or renew a season ticket between any station situate within a radius of 12 miles from Charing Cross Post Office and any station out-

side such radius. Provided that in determining whether or not a season ticket between such stations as aforesaid shall be issued or renewed to any person, regard shall be had to:—

(a) whether the ticket is required for travelling on business of national importance; and

(b) the place where the applicant ordinarily resides and the place where he carries on his profession, business or occupation; and

- (c) whether the applicant is at the date of his application the holder of a season ticket, and, if so, whether he first became the holder of a season ticket before the 1st January, 1917.
- (3) A Railway Company may require an applicant for a season ticket, or for the renewal thereof, to answer in writing such questions as they shall require to enable them to determine whether a season ticket ought to be issued or renewed to such person, and no person shall knowingly make any false statement for the purpose of obtaining a season ticket.
- (4) If any person is convicted of obtaining a season ticket by means of any false statement, the Railway Company which issued such ticket shall demand the surrender thereof, and such person shall thereupon return such ticket to the Company and it shall be forfeited.
- (5) A Railway Company may refuse to issue a season ticket for a distance over 12 miles to any person who is not at the date of the application the holder of a season ticket except for a period of not less than six months.
- (6) A Railway Company may refuse to agree to allow any rebate or to make any repayment in respect of a season ticket surrendered to the Company before the expiration of the period for which it was issued except in the case of—

(a) the death of the holder;

(b) the holder joining His Majesty's Forces or entering His Majesty's service.

(c) a person in the service of His Majesty who is obliged to change his residence by reason of such service.

- (7) This Order shall take effect as from the 21st day of May, 1918.
- (8) Infringements of this Order are summary offences against the Defence of the Realm Regulations.
- (9) This Order may be cited as The Railway Season Ticket Order, 1918.

DEFENCE OF THE REALM.

The Belfast Corporation (Tramways) Order, 1918, dated May 23, 1918, made by the Board of Trade under Regulation 7 B C of the Defence of the Realm Regulations.

The Board of Trade, pursuant to the powers conferred upon them by Regulation 7.B C of the Defence of the Realm Regulations as respects the tramway undertaking of the Lord Mayor, Aldermen and Citizens of the City of Belfast, hereby order as follows:—

1. In this Order "the Corporation" means

the Lord Mayor, Aldermen and Citizens of the City of Belfast.

- 2. Notwithstanding anything contained in Section 68 of the Belfast Corporation (Tramways) Act, 1904, the following provisions shall have effect (that is to say):—
 - (a) It shall not be obligatory on the City Accountant of the City of Belfast to include in any such estimate as is referred to in that section or on the Corporation to charge against the revenue of their Tramway Undertaking any sum by way of allowance for renewals or depreciation;
 - (b) The Corporation may from time to time in the course of any year revise all or any of the tolls, fares and charges to be levied by them for the use of their Tramways and of carriages and trucks used or propelled thereon as fixed at the commencement of such year; but so that the maximum fares, tolls and charges authorised for the time being are not exceeded;
 - (c) It shall not be obligatory on the Corporation so to fix the said tolls, fares and charges (whether at the commencement of any year or on the occasion of any such revision as aforesaid) that the revenue of the said undertaking for that year shall meet the expenditure as estimated for that year;
 - (d) If the said tolls, fares and charges shall for any year or on the occasion of any such revision as aforesaid be so fixed as not to meet the said estimated expenditure out of the said revenue for that year, any deficiency resulting therefrom which shall be realised may at the option of the Corporation either be disposed of in manner provided by the said section with respect to such deficiencies as are therein referred to, or be defrayed out of such local rates or funds as the Corporation may determine or be disposed of partly in one or more of those modes and partly in another or others of them.
- 3. This Order shall take effect as from the 23rd May, 1918.
- 4. This Order may be cited as the Belfast Corporation (Tramways) Order, 1918.

THE RAILWAYS (PASSENGER FARES) (IRELAND)
ORDER, 1918, DATED MAY 23RD, 1918, MADE
BY THE BOARD OF TRADE UNDER REGULATION
7B OF THE DEFENCE OF THE REALM REGULATIONS.

Whereas by Regulation 7B of the Defence of the Realm (Consolidation) Regulations, 1914 (inserted in those Regulations by an Order in Council, dated the 13th day of December, 1916), it is, amongst other things, provided as follows:—

"The Board of Trade may, for the purpose of making the most efficient use of railway plant or labour, with a view to the successful prosecution of the war, make orders for all or any of the following purposes, namely:—

equirements with respect to the maximum amount of passenger fares."

Now, therefore, in pursuance of their powers under the said regulation, and of all other powers enabling them in that behalf, the Board of Trade hereby order as follows:—

On and after the 1st June, 1918, the railway companies in Ireland may charge, in addition to the passenger fares contained in the lists exhibited at the stations at the date of this Order, a sum equal to one-half of such fares, or, where the fare is not contained in such list, they may charge one-half more than the maximum fare which would be chargeable but for this Order, and all such lists and all passenger tickets on which the fares are printed or written shall have effect as if the fares stated were increased by the additional sum so charged.

STATUTORY RULES AND ORDERS, 1918. UNEMPLOYMENT INSURANCE.

The Unemployment Insurance (Supplementary) Regulations, 1918, dated 17th May, 1918, made by the Minister of Labour under the National Insurance (Unemployment) Acts, 1911 to 1918.

Whereas by Section 91 of the National Insurance Act, 1911, power was given to the Board of Trade to make Regulations for the purposes therein specified and generally for carrying Part II of that Act into effect, and any Regulations so made are to have effect as if enacted in that Act:

And whereas by Section 2 of the New Ministries and Secretaries Act, 1916, it is provided amongst other things that the powers and duties of the Board of Trade under the National Insurance Act, 1911, as amended by any other Act shall be transferred to the Minister of Labour:

And whereas by Section 14, sub-section 2, of the New Ministries and Secretaries Act, 1916, it is provided that where any powers and duties are transferred by virtue of that Act the transfer shall take effect as from a date to be fixed by Order of His Majesty in Council:

And whereas by Order in Council dated 10th January, 1917, the said transfer was ordered to take effect as from the 10th day of Janu-

ary, 1917:

Now, therefore, the Minister of Labour, by virtue of the powers conferred upon him as hereinbefore recited and of every other power him hereunto enabling, doth hereby make the following Regulations:—

1. These Regulations may be cited as the Unemployment Insurance (Supplementary) Regulations, 1918, and shall come into force on the date hereof.

2. In proviso (a) to Regulation 11 (1) of the Unemployment Insurance Regulations, 1912, as amended by the Unemployment Insurance (Supplementary) Regulations, 1915, the words "two miles" shall be substituted for the words "three miles."

RULES PUBLICATION ACT, 1893.

In conformity with the provisions of the Statute 56 and 57 Victoria, cap. 66, notice is hereby given that the Secretary of State for India in Council proposes, with the advice and assistance of the Civil Service Commissioners, at the expiration of forty days from the date of this Gazette, to make an alteration as shown below in the Regulations for the examination of candidates for the Indian Civil Service, under section 97 of the Statute 5 and 6 George

V, cap. 61.
For the first part of Regulation 2, which at present stands as follows, viz. :-

"2. No person will be deemed qualified who shall not satisfy the Civil Service Commis--sioners:

(1) (a) That save as hereinafter provided he is a British subject.

(b) Inat if he (being a British subject) or his father or his mother was not born within His Majesty's Dominions and allegiance then at the time of his birth his father was a British subject and that such father still is or continued to be till his death a British subject."

It is proposed to substitute the following, that is to say:-

- "2. No person will be deemed qualified who shall not satisfy the Civil Service Commissioners:
 - (1) (a) That save as hereinafter provided he is a British subject.
 - (b) That if he (being a British subject), or his father or his mother was not born

within His Majesty's Dominions and allegiance then at the time of his birth his father was a British subject or the subject of any State in India, and that such father still is or continued to be until his death a British subject or the subject of such State in India.''

It is intended that the new Regulations shall apply to candidates at the open competitive examinations of 1919 and subsequent years.

(Construction of Reservoir on the Marshaw Wyre; Taking of Water and Repeal of present Limitation and Obligations; Compensation Water; Diversion of Footpath; Incorporation, Repeal and Amendment of Acts.)

OTICE is hereby given, that application is intended to be a second is intended to be made to Parliament in the present Session by the Mayor, Aldermen and Burgesses of the borough of Lancaster (hereinafter referred to as "the Corporation")

by petition for additional provision for leave to introduce into the Bill now pending in Parliament, under the above title (hereinafter referred to as "the Bill"), provisions and amendments to give effect to all or some of the following objects and purposes (that is to say):—

1. To empower the Corporation to divert, collect, impound, take, use and appropriate for the purposes of their water undertaking all such streams, springs and waters as can or may be intercepted or taken by the existing water-works of the Corporation or by the works authorised by the Bill, including the works hereinbefore referred to, or as may be found on, in or under any of the lands for the time being belonging to or which may be acquired by the Corporation, or over or in respect of which they have or may acquire easements, and especially the River Wyre and the tributaries thereof above the embankment of the Abbeystead Reservoir, including the Tarnbrook Wyre, the Marshaw Wyre, and the streams called Thrush Clough, Tarnsyke Clough, Thrush Clough, Tarnsyke Clough, Clough, Stick Close Beck, Wood Grizedale Brook, Higher Within ${f Thorn}$ Syke, Lower Within Syke and Castle Syke.

- 8. To empower the Corporation to deviate laterally and vertically from the lines and levels of the proposed works.

To empower the Corporation for the purposes of the proposed works, and for other the purposes of the provisions proposed to be added to the Bill, to purchase or acquire by compulsion or agreement lands, houses or buildings, in the parish, rural district and county aforesaid, and to acquire by compulsion or agreement rights or easements in, over or connected with any lands.

To extend and apply to the lands proposed to be acquired the provisions contained in the Bill excluding the provisions of the Lands Clauses Acts as to superfluous lands; conferring powers upon the Corporation as to the retention, sale and disposal of lands; making special provision in regard to the amount of compensation to be paid for lands taken and otherwise in regard to lands.
- 11. To empower the Corporation to borrow or raise money for the purchase of land and the construction of the proposed works, and for all other the purposes of the additional provision and to extend and apply thereto the provisions of the Bill relating to the borrowing, raising and repayment of money.
- 12. To extend and apply to the works proposed to be authorized and otherwise to the purposes of the Additional Provision the provisions of the enactments incorporated with the Bill, including the Lands Clauses Acts, 1847 and 1863, the Railways Clauses Consolidation Act, 1845, and the Waterworks Clauses Acts, 1847 and 1863.
