“The part of the Borough of Dover bounded by an imaginary line commencing at the point where the Borough Boundary is intersected by the south-western extremity of St. Bartholomew's Ward, thence following the southern Boundary of that Ward to its intersection with the Road from North Road to Priory Hill, thence along the middle of such Road in a southerly direction, thence along the western and southern sides of the Property in Westmount Terrace, and continuing in prolongation of the southern side of the said Property in an easterly direction to the middle of the Railway Line as it enters the tunnel north of Priory Station, thence along the middle of the Railway Line southward, across the Folkestone Road to the North Military Road, thence along the middle of such Road to a point where it would be intersected by a line drawn in continuation of Malvern Road, thence in a straight line in a south-westerly direction to the Borough Boundary at War Department Stone No. 37, thence along the Borough Boundary to the point first mentioned.

“The part of the Borough of Dover bounded by an imaginary line commencing at the point of intersection of the Boundaries of the Ancient Parishes of St. Mary, St. James, and Charlton in the River Dour, thence following the Boundary of the said Parish of St. Mary first south-easterly and then southward to the seaward Boundary of the Borough, thence along that Boundary in a westerly direction, and then northerly to the War Department Stone No. 37, thence along the south-eastern and eastern boundaries of the Hougham Ward to the point in the Road leading from North Road to Priory Hill where such boundary intersects the Boundary of the Parish of Charlton, thence along such Parish Boundary in an easterly direction to the point first mentioned.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 18th day of April, 1918, in the words and figures following, that is to say:—

“We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 23rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure of Seagrave, otherwise Segrave (hereinafter called ‘the said Benefice of Seagrave’), in the County of Leicester, and in the Diocese of Peterborough:

“Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Seagrave is vested for an estate in fee simple, in possession, free from incumbrances, in Mary Elizabeth Dalton, Spinster, and Emily Marian Dalton, Spinster, both of Number 12, Ulundi Road, Blackheath, in the County of Kent, and Frederick William Dalton, a Lieutenant in the Canadian Army, jointly:

“And whereas the said Mary Elizabeth Dalton, Emily Marian Dalton, and Frederick William Dalton are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Seagrave, now vested in them as aforesaid, should be transferred to and be vested in the Right Reverend Frank Theodore, now Bishop of Peterborough, and his Successors in the same Bishopric:

“And whereas the said Frank Theodore, Bishop of Peterborough, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the Diocese which, by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, he, the said Frank Theodore, Bishop of Peterborough, has executed this Scheme as hereinafter mentioned:

“And whereas the transfer of the Patronage of the said Benefice of Seagrave, which is hereinbefore mentioned, and hereinafter recommended and proposed, will, in our opinion, tend to make better provision for the Cure of Souls in the Parish or District in or in respect of which the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say, in the Parish of Seagrave:
